### EDITOR'S LETTER

Dear Members.

I sincerely apologize to all of you for being so late with the last two issues of this year's Strickland Scene. By now, most of you know I am often late, but I did not intend to be THIS late.

Our Annual Meeting on October 27 and 28 was enjoyed by all. If you did not attend this year's meeting, start making plans to be with us next year. You are missing a lot of research and a lot of good socializing by not joining us.

On Saturday, we met at the Strickland headquarters. After a light lunch, we enjoyed a talk and slides by Imogene Bowen on how she searched for her Stricklands through deed records - or, as she puts it - "If you can't find your ancestors, look for their friends and neighbors." We also enjoyed Emogene McKinney's brief talk on how she tracked down her Strickland ancestors. The afternoon was spent searching through the files and books, and comparing notes with each other. Even though our workshop ended around 6 o'clock, I later learned a number of members gathered in one of the Century Inn rooms and continued their discussions and note comparisons until the "wee hours."

On Sunday, our luncheon was held at Century Airport Inn and our speaker was Mr. Leward Dunn, State Secretary and Registrar for the Georgia Society of the Sons of the American Revolution. His lecture was "Preparing Your Lineage For A Patriotic Society." Lewie is a member of Strickland Research and has recently proven his Strickland lineage for the SAR.

A Board Meeting was held on Saturday afternoon, and the following recommendations were read and approved in the Annual Business Meeting on Sunday. Effective immediately, our dues will be increased from \$10 per year to \$12.50 per year. Since postal and printing costs have continued to escalate, those present felt we needed an increase to cover the additional costs. A second recommendation was made to actively seek a qualified genealogical researcher in England to begin a search for Stricklands who migrated to America. L. C. Strickland was appointed by the President, Freeman Strickland, to write several researchers and determine basic costs. Even though the

current amount in our Research Fund may not be nearly enough, the Board decided it was time to look into the possibilities. If you have not made a donation to the Research Fund, why not make a donation this year - it is a tax deduction since we are a non-profit organization.

I know I promised to print an index to the Strickland Document Files in this issue. However, since they are in the process of being renumbered, I will have to wait until the next issue to begin this index. If you have ordered copies from the Ancestor Files, please be patient with me. Not only have I been without a car for the past month, the xerox machine nearby has been "out of commission." I hope to get this backlog of work done in the next few weeks.

Mrs. J. Arthur Parker (Lurline Davis) of 913 First Street, Lanett, Alabama, died July 26, 1984. OBITUARY OF MRS. CARRIE STRICKLAND ALLEN OF BLACKSHEAR, GA Waycross Journal-Herald, Tuesday, July 3, 1984

Mrs. Carrie Strickland Allen, 74, died Monday morning at Memorial Hospital in Waycross after a brief illness. She was a former schoolteacher and was a member of Blackshear Presbyterian Church. She was born in Ware County but had resided in Pierce County most of her life.

She and her husband, W. Riley Allen, celebrated their golden wedding anniversary in 1978. Her parents were the late Johnnie Strickland and Missouri Ann Woodard Strickland.

Besides her husband, she is survived by two daughters, Mrs. Brownie Smyre, Gastonia, NC, and Mrs. Patricia Aunan, Lake Bluff, IL; two sons, Raymond M. Allen, Greenville, SC, and W. R. (Butch) Allen II, Jacksonville, FL; and seven grandchildren.

### ORIGINAL PAPERS FROM FRANKLIN COUNTY, GEORGIA

The following list of abstracts are taken from the original (loose) papers which are presently stored at the Georgia Department of Archives & History, Atlanta, Georgia. Perhaps these papers are the foundation for the often told story of a Wilson Strickland who killed a black man and had to leave the state of Georgia. It is apparent, however, that the Wilson Strickland mentioned in the following was not out of the state for very long because, a few years later, he is summoned into court to settle a land dispute. This Wilson appears to be the son of Jacob and Priscilla Young Strickland who married Polly Connally and died in Gwinnett County, Georgia, in 1841. The Mary Gilbert Allen is his sister; James Allen is Mary's second husband; and Isaac Strickland is Wilson's brother. "Lby Vaughn" is probably Littleberry Vaughn who married Sarah (Sally), Wilson's sister. Henry Strickland and Hardy Strickland, mentioned in Isaac Strickland's "answer" as defendant against Wilson Strickland, are brothers of Isaac and Wilson.

- 1. Bond of Hardy Strickland and Mary Gilbert for Wilson Strickland to appear in "next Superior Court" dated 11 May 1805 signed: Hardy Strickland; Mary Gilbert witnessed by M. Wilson.
- 2. "This day personally came before me...Willson Strickland and surrendered himself...for shooting a negro fellow names Ben who was under him as an overseer and belonged to the estate of John Gilbert, deceased." Signed: M. Wilson, JP witnessed by James Allan.
  - James Allan posted \$500 Bond to appear at next Superior Court (2nd Monday in October) to give testimony against Willson Strickland dated 11 May 1805.
- 3. Notice from Superior Court, Western District of Georgia: "To Hezekiah Jerrell, sheriff of Franklin County...whereas Hardy Strickland and Mary Gilbert, now Mary Allen, were bail for the appearance of the said Wilson Strickland (at October term)...and the said Wilson Strickland being three times solemnly called and failing to appear,...command you to summon the said Hardy Strickland, James Allen and Mary Allen to be and appear at the next Superior Court ...upon the 2nd Monday in April next, then and there to show cause, if any they have, why their Recognizance should not be Entreated & final judgement enter thereon...

(On 16 April 1806, none of the above appeared and they were required to pay the sum of one thousand dollars.)

- 4. "Artickles of agreement between Isaac Strickland of the one part & Wilson Strickland of the other part, Both of the county of Franklin & state of Georgia the sd. Isaac Strickland Doth agree to Rent to the sd. Wilson Strickland all that plantation whereon the sd. Wilson Strickland now lives on for Eighty Dollars Cash paid By the twenty day of December next or otherwise give one third of All corn & other wheat, Rye or oats that is maid on that place this year. Witness By nad this 14th day of February 1809. (signed) Wilson Strickland
- 5. "Mr. Wilson Strickland

"Sir, Please to take notice that I am sued as casual (?)
Ejector of the said tract of land above described, and as I understand you

have some title to the said tract of land or some part thereof; I therefore advise you to appear at the Superior Court to be held in and for said county on the Second Monday in October next and cause yourself to be entered a defendant in the above case in my stead, otherwise I shall suffer Judgment to go against me, and you will be turned out of possession.

17th August 1810

From your loving friend, Richard Roe"

- 6. Subpeona for David B. Driscal to appear in Superior Court as a "witness between Isaac Strickland, plaintiff, & Wilson Strickland, defendant, & this subpeona is issued by request of the defendant..." dated 23 March 1811.

  (Note: David B. Driscal traveled "the distance of sixteen miles" to appear in court.)
- 7. "Georgia, Franklin County To Isaac Strickland, Greeting

  For certain causes offered before us in our said Chancery
  Court in Said County, we Strictly enjoin you that...you be before us in our
  said Chancery on the Second Monday in October next then and there to answer
  the demands of Wilson Strickland Complainant in a bill in equity against
  Isaac Strickland, respondant..." dated 14 April 1812
- 8. Wilson Strickland gave security for all cost "which may be incured upon an appeal case in said county..." on the 14th of April 1812.
- 9. "Wilson Strickland vs Isaac Strickland Bill of Equity & Injunction, Superior Court Franklin County: Answer of Isaac Strickland, the Defendant

"The defendant Isaac Strickland...reserving to himself all and all manner of advantage of exception to the many untruths, errors, uncertainties, and other imperfections in the said Bill of Complaint contained for answer thereunto...saith, That he admits it to be true that Wilson Strickland was at the time specified...charged with the crime of murder in the County of Franklin, and might for what this defendant knows be ignorant of the laws of the land, and might have absconded in the manner stated in the complainants Bill of Complaint to avoid a prosecution for the murder...This defendant also admits that it may be true that the said Mary Gilbert & Hardy Strickland might have become bail for the appearance of the Complainant Wilson Strickland. This defendant admits also not knowing the motives of the complainant, nor his ignorance of legal proceedings, that he did execute a Deed of conveyance to Henry Strickland who was the brother of the Complainant and this defendant for a tract of land said to contain two hundred eighty-seven & one half acres... This defendant admits that he received a conveyance from Henry Strickland now deceased for the tract of land conveyed by Wilson Strickland to Henry Strickland...but denies...that the conveyance was received without any consideration but...with the express consent of the complainant Wilson Strickland, this defendant took and received the conveyance for the tract of land...and paid...at the solicitation of Wilson Strickland and Henry Strickland, now deceased...to Hardy Strickland and James Allan the sum of five hundred dollars cash all in gold and silver except one ten dollars in paper money, making in the wholeone thousand dollars ...which sum of money this defendant understood and believed was to save the said Hardy Strickland and James Allan harmless from the recognizance, before that time entered into by the said Hardy Strickland and Mary Gilbert, with whom the said James Allan afterwards intermarried...this defendant knowing that the deed from the Complainant was duly recorded and knowing that he...

had paid a full and valuable consideration for the Land, received the Deed from Henry Strickland believing him to have the legal title...and this defendant upon this express condition that if the complainant paid to this defendant the one thousand dollars which this defendant had advanced to Hardy Strickland and James Allan...then he, this defendant, would give up the tract of Land received from Henry Strickland...This defendant admits that he did apply to the complainant for his note for the rent of the Land, as he, this defendant, conceived his duty, the Land being this defendants property and the said complainants enjoying the same...This defendant saith that he verily believes that Henry Strickland paid to the complainant in presence of this defendant for the tract of Land and other property bargained for at the same time, between twelve and eighteen hundred dollars in specie. This defendant admits that he was one of the witnesses to and proved the Deed made by Henry Strickland to the complainant. I also leave to my son BRITTON STRICKLING one bed, bedstead and furniture also five Head of hogs and one cow and calf likewise, one pot and one ax.

Itam - I give and bequeath to my daughter MARY STRICKLAND one bed, bedstead and furniture also one loom and gears. Likewise one linnen wheel and one skillet and all my cotton.

All the rest of my estate I leave to be sold and the money Equally divided between my sons and daughters.

This I certify to be my Last will and Testament signed in presence of us - January the 25th day 1807.



### LEVI J. STRICKLAND (1812-186?) Contributed by Margaret Major

LEVI J. STRICKLAND was born in 1812 in North Carolina. His parents came to Georgia in 1820. Levi J. settled in Ware County, Georgia, about 1858 in the area that became Pierce County. Levi J. was a private in Captain James A. Sweat's Company of Ware County militia in the Indian War of 1838 for four months (9 June 1838 to 19 August 1838). He was absent from 31 August to 21 December 1838. Levi J. was awarded land for his service. He made application for a Bounty Land Grant for his service in the Florida Indian War (Seminole). It was approved and land was granted. In 1865, Levi J. moved to Brantley County, Georgia, where he was a pioneer farmer of Brantley County. He lived there until his death.

LEVI J. STRICKLAND first married Miss MARTHA HIERS of Appling County, Georgia. She was born in 1819 to Joseph and Patsy (Strickland) Hiers. She died in 1839 in Pierce County, Georgia (then Ware County). The children of Martha and Levi J. Strickland were:

WILMA STRICKLAND COATS, 801 Ohio St., Bicknell, Indiana 47512: Need information on Wiley STRICKLEN/STRICKLAND who was the father of John R. STRICKLEN, married 2 August 1845, Craven Co., NC, to Eleanor JOHNSON. Entire family, per legend, were killed before 1850.

Two sons were not killed - John R. and a brother? John R. served Confederacy during

Civil War, was in home of Brittain and Edy STRICKLAND on 1850 Census of Floyd Co., KY. Need any information I can get, especially about Wiley STRICKLEN.

STRICKLAND BOLTON BUNN MARRIOTT PERRY GRIFFIS TEMPLETON McDANIELS WOMACK EDDIE WOMACK, Box 63, Wilburton, OK 74578: It is believed that Obediah Powell STRICKLAND was born in Wake Co., NC in 1806. He married Mary (Polly) BOLTON, December 9, 1826 in Wake Co., NC. This is our first contact. They had two boy in NC - Wesley B. and Augustus G. Then sometime in early 1830's they moved to Pickens Co., AL, in a two wheel ox-cart with an uncle, Cade BUNN. He lived with them until he died. We believe Matthew STRICKLAND Jr. could be the father of Obediah P. (my great grandfather).

We think Matthew STRICKLAND Jr. married Nancy BUNN January 10, 1803, and that Obediah P. is the child of that marriage. We have no proof of this as we have information from another source that Matthew STRICKLAND Jr. married Elizabeth MARRIOTT November 27, 1811. This is the missing link in our lineage. Matthew STRICKLAND Sr. of Wake Co. married Mary PERRY and had Jr. and John Perry STRICKLAND as well as several daughters. We have traced the line back to Matthee STRICKLAND Sr. of Isle of Wight, VA, d. 1699. We need to know:

- 1. Are Matthew STRICKLAND and Nancy BUNN parents of Obediah P. STRICKLAND?
- 2. Were Nancy BUNN and Cade BUNN brother and sister?
- 3. Who was their father and mother?

Children of Obediah P. STRICKLAND and Mary BOLTON:

- 1. Augustus G. STRICKLAND went to Cass Co., TX, about 1850 & married Catherine Melissa GRIFFIS about 1855. They had ten children. Augustus was born in NC in August 1827 & died 1910 (kicked by horse).
- 2. Wesley B. STRICKLAND, born 1829 in NC, married Harriet E. TEMPLETON in MS Jan. 28, 1859. They had 7 children. Wesley moved to Indian Territory (OK) in 1893. His wife stayed in AL. Wesley d. 1915 near Red Oak, OK.
  - 3. James N. STRICKLAND, born about 1832. Nothing else is known.
  - 4. Polly STRICKLAND, born c. 1834 in AL.
  - 5. Susan STRICKLAND, born 1836, Pickens Co., AL.
  - 6. Pennina STRICKLAND, b. 1838, Pickens Co., AL.
  - 7. Angeline, b. 1840, Pickens Co., AL.
  - 8. Bethina, b . 1842, Pickens Co., AL.
- 9. Jasper Newton STRICKLAND (my grandfather) was born in Pickens Co., AL, 1846. Married Savannah McDANIELS c. 1869. They had ten children. They separated in 1891 and Savannah and the children came to Indian Territory (OK in 1891) where she lived until she died in 1916. Jasper died in Arkansas c. 1929. My mother, Nancy Della STRICKLAND, married Napoleon B. WOMACK in Indian Territory in 1899. They had nine children of which I am the youngest. My wife, Weta Muse WOMACK and I have two grown children.
