David Strickland has had a good response to his request for Strickland family group sheets for publication, with the first volume nearing completion. David, a member from our first year, will be providing these at cost. He adds that the project is involving about three times the work he anticipated!

This price information was received after the notice on the following page was printed. We are glad to have Mrs. Curtis's involvement, and wish her a rapid recovery from a broken wrist!

Mrs. Mary Barnett Curtis, a Strickland genealogist for 40 years, and possessing probably the largest trove of Strickland genealogical material in existence, is offering our members her North Carolina Strickland Research Notes, a 125 page compilation of 17th-19th century genealogical records grouped chronologically under county and individual, at \$45 postpaid (a 10% discount from her regular price). Though the content of this 1976 book is extensive, she emphasizes it does not contain all she now has. (An index to this work, with over 3,000 entries, is now available for \$5 from Strickland Research, Inc.)

Also available from Mrs. Curtis are reprints of The Strickland and Allied Families Query and Answer Exchange, originally published by her from 1959-1964, at \$35 postpaid for the complete set. Each issue of S&AFQ&AE is full of queries raised a generation ago and genealogical data of enduring value.

THE FAMILY OF ALEXANDER STRICKLAND (1827-1909)  
OF MURRAY & WHITFIELD COUNTIES, GEORGIA & LOGAN COUNTY, ARKANSAS

Alexander Strickland was born 1 Apr 1827 GA. On 18 Feb 1850 he married Mary Jane Wilson, born Aug 1830 TN, daughter of W. M. Wilson. He was a farmer. He was part Indian (some older family members say his mother was full blood Indian who had walked the Trail of Tears from Georgia to Oklahoma in the 1830's). They separated before 1900. Alexander d. 29 Dec 1909 at Booneville, Logan Co AR, and was buried at Golden City Cemetery. She died 5 Mar 1912 in Joplin MO, where she is buried at Peace Church Cemetery.



Their children were: Millie J., b. 18 Nov 1850 in Murray Co GA, m. Tom Shephard ca. 1872 in MO?, & d. ca. 1935 in Long Beach CA; Henry, b. 18 Feb 1852 Murray Co GA, m1. Betsy Kennson ca. 1877 AR, m2. Millie Ellen Marljar ca. 1879 Logan Co AR?, & d. 18 Jan 1927 Logan Co AR, bur. Golden City Cemetery; William b. ca. 1854 GA, m. Rebecca Marljar ca. 1880 prob. MO (maybe KS), he was a U.S. Marshall, shot & killed on duty ca. 1896; John William, b. ca. 1858 GA, d. ca. 1876 Indian Territory (later = Oklahoma); Sarah Ellen, b. 18 Nov 1860 Whitfield Co GA, Kenyon Mortimer Lemmons 8 Apr 1877 Logan Co AR, & d. 15 Apr 1890 Joplin MO; and James Llewellen, b. 21 Mar 1863 Whitfield Co GA, m. Sarah Effie Perry 1 Aug 1880 MO, & d. 6 Feb 1938 Los Angeles CA.

Henry & Millie (Marlar) Strickland ca. 1920 in Sugar Creek (Golden City) near Booneville AR. Henry was b. Murray Co GA, the son of Alexander Strickland (1827 GA - 1909 AR) & Mary Jane Wilson (1830 TN - 1912 MO).

Their son Henry also was a farmer, and at one time was a deputy marshall on the Santa Fe Trail. Though part Indian, he hated them & disclaimed that heritage. He first married Betsy Kennson ca. 1878 in Arkansas, and had a daughter Wincy who married a Wilkins. He & Millie married ca. 1879 either in Joplin MO or they moved there from Logan County AR shortly after their marriage. Millie was born 22 Apr 1855 in Sebastian Co AR and d. at Sugar Creek, Logan Co AR 5 Mar 1925. She had been married first to a Jones, and her daughter by that marriage, Sally, married a Miller.

Henry's and Millie's children by their marriage were: Hattie Mae, b. 3 Oct 1879 AR, m. John Spencer, & d. 5 Sep 1929 AR? childless; William Dee, b. Feb 1882 AR, m. in AR or OK to Zahara Myrtle Garner (b. AR/OK, d. ca. 1971/72 Oklahoma City), & d. in 1950's at Oklahoma City [their children were Rebecca (1907-14 Mar 1986), m. George Best; Orville, m. Mary (?) who d. Oct 1984 Long Beach CA; a son J. T. in Moore OK; Estelle, d. ca. 1973 Oklahoma City; and Zula Dean Lake in Ocean Pines MD]; Alexander Thornton, b. 2 May 1884 Joplin MO, d. 1 Aug 1951 Fresno CA (see below); James Llewellen, b. 23 Dec 1888 Fort Smith AR, m. Sallye Evelyn "Evie" Crabtree 12 Jan 1908 Logan Co AR, & d. 9 Mar 1949 at Booneville, with burial at Oak Hill Cemetery; and John

H., b. ca. 1891 AR, m. Lettie Robinson in AR?, childless, d. Feb 1918 in World War I, buried in National Cemetery, Fort Smith AR.

Alexander Thornton Strickland was a World War I infantry sergeant & farmer, with striking blue eyes, dark brown hair, light complexion, 5'10" in height. He first married Pearl Wimberly (b. GA) before 1919 in Chattanooga TN, and secondly ca. 1929 in Oklahoma City Laura Bunch, b. 18 Jul 1888 in East Texas (her name was Ward in 1982 at time of her death in OK) with whom he had a son, Tommy Alexander ("T.A.") b. 6 Jun 1930, and lastly on 23 Jan 1932 in Booneville AR to Nola Brooks, b. 2 Apr 1899 Cardiff AR, d. 18 Nov 1981 in Fort Smith, bur. at Booneville AR, the daughter of James S. and Anna (Rowland) Brooks. She was married first to Nelson K. Shirley (1869-1929), with whom she had one daughter, Arlie Bess Shirley Clark. Alexander T. and Nola had two daughters, Millie Ann Cress, b. 18 Nov 1932 at Sugar Creek Logan Co AR and Nola Estelle Hartsfield, b. 9 Mar 1934.

Alexander T. Strickland

REEDLEY, Fresno Co., Aug. 2.—Alexander Thornton Strickland, 67, of 2203 Eleventh Street, died late yesterday in a Fresno hospital after a long illness.

He was a veteran of World War I and had been in the Oak Knoll Veterans Administration Hospital in Oakland five months. He lived in Reedley four years.

He is survived by his widow, Nola; a son, Thomas Strickland of Oklahoma; three daughters, Mrs. Millie Tatum and Estelle Strickland of Reedley and Mrs. Arlie Clark of Modesto; a brother, W. D. Strickland of Oklahoma, and a sister, Mrs. Sarah Miller of Arkansas.

The funeral arrangements are being made by Stephens & Bean in Fresno.

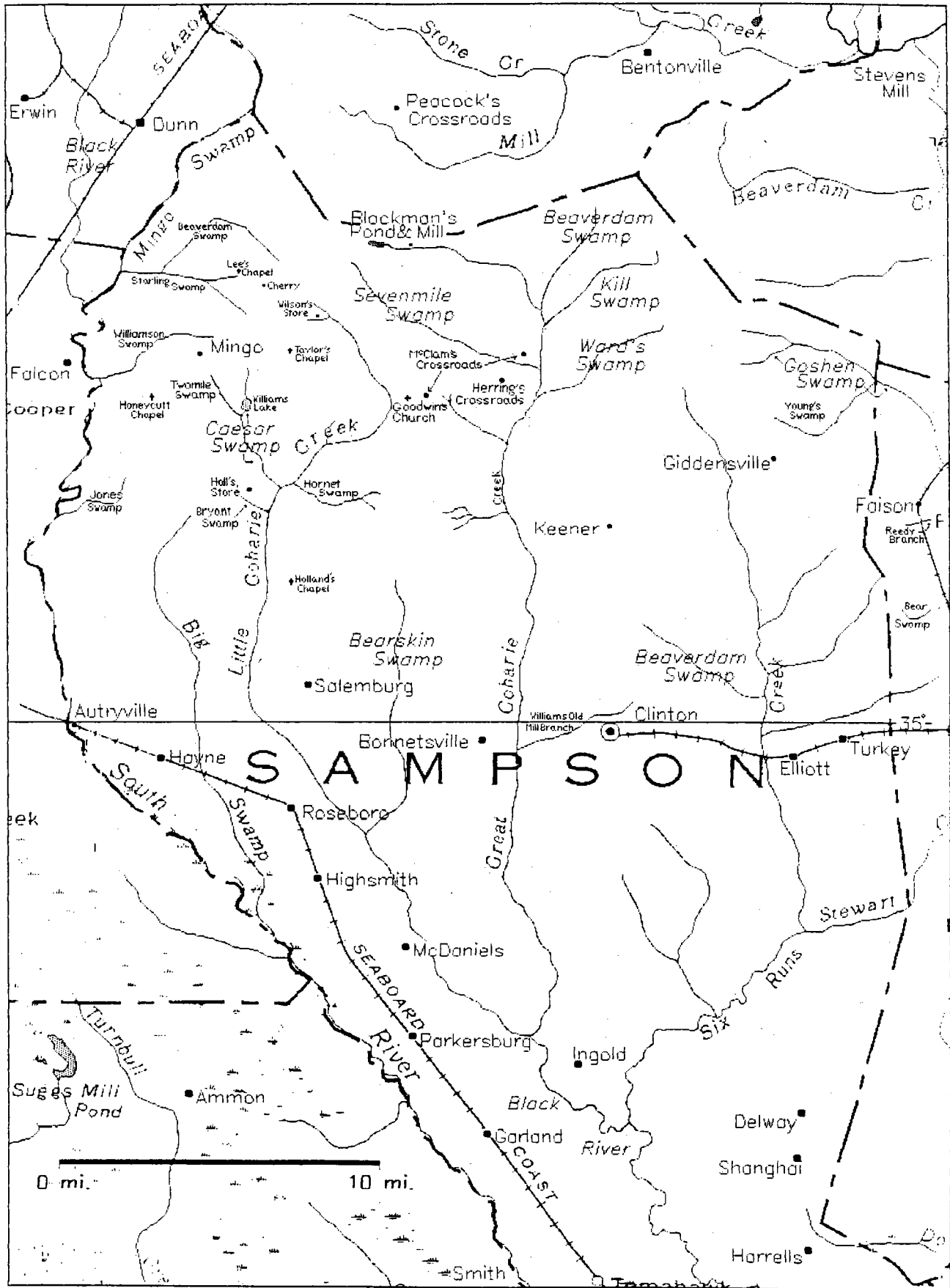

Some present day place names on the accompanying Sampson County map may be cross-referenced to the deed records more readily than others. Many geographic features (branches, swamps, ponds & pocosins, et al.) exist that are unnamed on the U.S. Geological Survey maps from which the preceding map was compiled. Purdom Swamp was not found. Most major watercourses had a tributary named "Beaverdam Creek" or "Beaverdam Swamp". There was more than one Williams Pond or Lake, two McClam's Crossroads, etc. Hall's Store, Chapel and Cemetery were in the same general area, but miles apart. Goodwin's Chapel is far from the Cumberland County town of Godwin (unmarked, but along the Seaboard Line RR near Falcon).

Downstream from their confluence, the Great Coharie and Little Coharie become the Black River, while the South River (the boundary between Sampson and Cumberland Counties) begins where the Black River of adjoining Harnett County meets the mouth of Mingo Swamp (the boundary between Harnett and Sampson Counties); on 18th century maps the name Black River was (sensibly) given to the entire watercourse, upstream and down, and the midpart now called South River. Adding to uncertainty, old maps imprecisely show two branches east of the Black River headwaters, "Black Creek Swamp" and "Black Mingo", in the approximate relative position of present Mingo Swamp and Starling/Beaverdam Swamps.

The name Coharie refers to the Coharie Indians who inhabited the area. A "pocosin" or "pocoson", a word of Indian origin, is an area of low ground, miry in the summer, and covered with shallow water in winter, sometimes with no or only a little outlet (a "blind pocosin"). Mingo as used here probably meant a place where a band of Indians had resided; Black Mingo would describe a deep darkly gladed mingo, as a forest or swamp could be called "black". It is hoped that the map will help our research more than it confuses!

STRICKLAND Lee Strom Guerra (Mrs. Frank Guerra), 124 E. Main Street, Bergen-  
 FENWICK field NJ 07621: [Ed. Note: This data, received after the query on  
 SEAMAN the next page was printed, amplifies & supersedes that information.]  
 LOAM John Strickland, b. ca. 1600, arrived Oct 1629 (prob. from Boynton  
 LUM Manor, Yorkshire) with the Winthrop Fleet accompanied by his wife  
 WOOD Jane Fenwick, son Thwaite (b. ca. 1618, d. 1670 Hartford CT), 3  
 SMITH daughters Elizabeth (b. 1623) (my ancestor), who later m. Capt. John  
 MATTHEWS Seaman, Joanna, who m. Jonas Wood, and (?) (b. 1625), who m.  
 John Loam (Lum) & John's 19 year old brother Edmund. He settled  
 first at Charlestown MA, then removed to Wethersfield CT, Fairfield CT, Hempstead, Long  
 Island, Huntington, L.I., & d. 1692 at Jamaica L.I. He served under Capt. John Seaman  
 (later his son-in-law) in Pequot Indian Wars. Two other daughters were Sarah, b. 1630  
 Charlestown MA, who m. John Smith, Jr., and Susanna, b. 1632, who m. Samuel Matthews.  
 John was widowed after 1644, and is supposed to have married twice again.

STRICKLAND Barbara Inman Henry, POB 148, Oakville WA 98568: My great-grandmother, Sarah Jane Strickland, b. 15 Mar 1840 Macon Co GA, was a daughter of Hardy Strickland b. ca. 1813 GA and his wife Sarah (nee Higginbothen) b. ca. 1815. She married Junius Augustus Inmon/Inman on 27 Jan 1859. On the 1860 census of Columbia Co AR the following were together in one household: H(ardy) Strickland 47 GA; Sarah (nee Higginbothen) 45 GA (wife); Elizabeth 10 AL; Georgia 8 AL; W. Higgenbothen 25 AL; Eleanor A. 22 GA; Sarah 6 AL; Ezekiel 3 AL; and Ann 1-1/2 AL. Is anyone familiar with that line?

STRICKLIN Kristine Bruins, POB 279, Parma ID 83660: I need information on STRICKLAND Redmon Stricklin (Strickland) b. 1792 TN, d. 1848 IL, m. Phoebe PENCE (?), b. ca. 1800 GA, d. 1849 IL. They resided first in TN and then in Madison Co IL in 1820, settling in Greene Co IL by 1830 where they both died and are buried in Carrollton IL. They had at least 10 children: William R., b. 1817, m. Christiana Pence; HACKNEY Catherine b. 1823, m. Joseph Hackney; JOHN N., b. 1829; Louisa, b. 1831, m. James Allen; Frances M., b. 1833; Marshall W., b. 1836, m. Margaret Goff; HARVEY, b. 1840; George, b. 1843; and Winfield Scott, b. 1847. All the children were born in IL except William R., who was born in TN. Who were Redmon's & Phoebe's parents?

STRICKLAND Lee Strom Guerra (Mrs. Frank Guerra), 124 E. Main Street, Bergenfield NJ 07621: I would like to know more about JOHN STRICKLAND SEAMAN from whom I descend. I understand he came from Westmoreland County STAMBROUGH England, that in 1629-30 he was an original settler of Charlestown MA, that he was a disenchanting puritan, that from MA he removed to Wethersfield CT and from there to Fairfield CT where his daughter, Elizabeth, married Capt. John Seaman of Stamford CT ca. 1642-44. They all went to Long Island in 1644. Elizabeth's mother was either Jane (?) or Mary Stambrough. John Strickland was a sergeant in the Pequot Indian Wars and was the first deputy from Fairfield to the CT legislature. He was also a magistrate in Hempstead, Long Island. He died 1672 in Jamaica, L.I. He had a brother Edmund.

STRICKLAND Debra M. Lyddon, 9517 Meadow Drive, Omaha NE 68114: I descend SEAMAN through Capt. John Seaman and Elizabeth Strickland of Hempstead, Long Island. Elizabeth's parentage is unclear - was Elizabeth's father John, or was it Edmund? I am anxious to write to anyone interested.

STRICKLAND Marie Green Bryant, 6 Cornus Court, Savannah GA 31406: I am seeking MARTIN information on Ellen Ophelia Strickland b. ca. 1830. She reportedly CLANTON was the daughter of John Strickland, b. 7 Sep 1804, d. 17 Apr 1879, son of David Strickland, and John's wife Marcey Martin Strickland, of Bulloch, Bryan, Ware and Pierce Cos GA. Is Ellen Ophelia the same as Eleanor Strickland who appears as the daughter of John in Bulloch Co Common School Fund records? The last child listed, Angeline, has the same birthday as Angeline, d/o John, in Wiregrass v.1 p.265. This Eleanor has birthday of 23 Apr 1830. Ellen Ophelia Strickland m. John Daniel Clanton ca. 1847. She d. 14 Dec 1919 in Bryan Co GA.

STRICKLAND Buckie R. Strickland, Route 6, Box 394, DeFuniak Springs FL 32433: BLANKSHIP My greatgrandfather was Jessie Andrew Strickland, son of Richard & HAND Elizabeth (Betsy) Strickland. I don't know who Jessie married. His FARMER son, my grandfather, was Franklin Andrew Strickland, Sr., born 1 Apr 1886, who on 8 Dec 1907 married Jennie Blankship Hand, born 14 Jan 1891. My father, Franklin Andrew ("F.A.") Strickland, Jr., born 14 Aug 1921, on 13 Dec 1941 married Effie Belle Farmer, b. 9 Sep 1924, and I was born Aug 1942 in Walton Co FL. I'll appreciate any help with my line.

STRICKLAND Kenneth L. Strickland, POB 63, Morganton GA 30560: My line is through my father Kenneth Lamar Strickland b.1916, s/o Willis Howard Strickland (1892-1971), s/o Kinchen Dabney Strickland (1847-1919), s/o Willis Strickland (1805-1862), s/o Kinchen Strickland (1780-1863), s/o Elisha Strickland ( - 1795), s/o Jacob Strickland ( -1790), s/o Matthew Strickland, Jr. ( - 1730), s/o Matthew Strickland, Sr. ( -1691). I am interested in all information on the early Stricklands.

STRICKLAND Rebecca Christensen, 3154 Pearl Drive #3, Fullerton CA 92631: In Dec 1797 a deed from Nathan Strickland to Frederick Massey was proved by GIBSON Thomas Massey, a deed from Sampson Strickland to Frederick Massey ANDERSON was proved by Thomas Massey, and a deed from Frederick Strickland MASSEY and Nathan Strickland to Frederick Massey was proved by Thomas Massey [viz. Weynette Parks Haun, Wake Co NC County Court Minutes (Court of Pleas & Quarter Sessions), 1797-1800, Book IV, p.45 (p.298 of original record)]. Frederick moved to Abbeville District SC ca. 1797. There in Feb 1814 Frederick Strickland & Nathan Strickland, Sr. inventoried the estate of Jacob Strickland. What are the relationships between Frederick & Nathan & Sampson? Frederick was b. ca. 1741. Nothing is known about his parents or siblings. He married Mary Gibson and had the following known children: Zachariah, b. ca. 1770; John, b. ca. 1774; Warren Gibson, b. ca. 1775-80, who m. Mary Anderson of Abbeville SC; James, b. ca. 1776; Malachi, b. ca. 1787; and Ruth, birthdate unknown.

STRICKLAND Robert C. Stricklin, Route 1, Box 539, Warrenton OR 97146 (1989  
STRICKLIN address: POB 1931, Dallas TX 75221-1931): On 4 June 1810 in  
BRYANT Humphreys Co TN, Elihu Strickland and John Moore witnessed the deed  
SAVAGE of Richard Simmons to James Garret for 50 acres on the north fork of  
SAVIDGE Blue Creek (deed recorded 22 Jul 1812 at Book A, p.103). On 18 June  
REGION 1814 in Hickman Co TN, Elihu Strickland and Stephen Strickland  
MOORE witnessed a deed from Jones Mercer to John Bryant for 20 acres on  
SIMMONS Hurricane Creek. This deed mentions the southeast corner of Thomas  
GARRET Hambleton's survey. On the same date Elihu Strickland and Samuel  
MERCER Strickland witnessed a second deed from Jones Mercer to John Bryant,  
HAMBLETON for land on Hurricane Creek, which deed mentions John Page's  
PAGE southeast corner. These last two deeds were recorded 4 Dec 1821, at  
pp.497-498 of the county deed records. [This data is from The River  
Counties, v.6 (1977) p.90 and v.9 (1980) p.33, in the Dallas (TX) Public Library.  
It appears that the above Stephen Strickland: (1) was with Elihu on a list of the free  
taxable inhabitants of Humphreys Co TN for the year 1812 (Ansearchin' News v.? p.161);  
(2) was subscribed (as "Stephen Streakelen") with John Striclin, Luke Striclin &  
Benjamin Stricklin (whose given names match those of 3 of Stephen's children who at  
the time were unborn, 9 and 4 years of age respectively) to an 1819 Perry Co petition  
(River Counties v.1 1972 p.9); and (3) lived from ca. 1785/86-1865, appearing on the  
Perry Co TN census 1820-1860, with place of birth shown as TN and OH, some of whose  
children lived in Dade Co MO, and whose son Thomas lived in Hunt Co TX. In 1840 a  
Samuel Stricklin household (1m 80-90, 1m 40-50, 1f 30-40, 1f 10-15) was on the Hickman  
Co census between Katherine Region and Asa Savidge; in 1850 Elizabeth Strickland age  
24 b. TN lived with the family of Perkins Savage. How were Elihu, Stephen, Samuel,  
Luke, John & Benjamin Strickland/Stricklin related? From what branch did they descend?
