FOREWORD

The minutes of the Confederate Veterans Association of Tyrrell County are contained within a bound booklet with numbered pages. The following transcription is shown exactly as it appears in the booklet, which I transcribed from microfilm. The rosters contained herein provide names of members and deaths among the members. An index of every name shown in the minutes has been added at the end of the minutes.

In addition to the minutes, a summary of the service records and any pension records have been added for each member of the Confederate Veterans Association. The few members for whom records could not be found were probably members of the partisan ranger unit commanded by William H. Spencer. There are no records of this unit except for a list of prisoners captured at Fairfield in Hyde County. Service records have also been included for five veterans receiving medals from the United Daughters of the Confederacy mentioned in the minutes who were not members of the Association.

Service records do not tell you the movements and battles that each soldier participated in, so I have added three short histories of the units that most of these veterans served in. This will allow readers to put the service record of these veterans in context and appreciate their trials and tribulations.

My interest in transcribing these minutes stems from the fact that I have been a student of the Civil War from the time I was a child, who started out by reading Bruce Catton's Trilogy. Three of my great-great-grandfathers from Tyrrell County served in the Confederate Army, James J. Barnes and George W. Brickhouse in the 1st NC Infantry Regiment and George W. Merritt in the 32nd NC Infantry Regiment. My other great-great-grandfather from Tyrrell County, Abram Rhodes, was too old to serve, but his son, John W. Rhodes, served in the 32nd NC Infantry Regiment. Strangely, James J. Barnes also later served in the Union Army. My interest in these minutes was also due to my great-great grandfather, George Merritt, being a member of the Association.

On motion of Comrade Alexander the Association adjourned to meet the 4th day of next July.

Confederate Veterans Association met August 20, 1890 and the following business was transacted.

The Association was called to order by Comrade T. L. Jones. Prayer by Rev. Mr. Holden of the M. E. Church South.

Roll was called and absentees noted. Comrade Levin Godwin died since our last meeting.

The Association then proceeded to elect officers for the next year. Resulted as follows.PresidentT. L. JonesVice PresidentAb AlexanderSect.C. E. Tatem

Comrades J. L. Cooper, A. H. Tatem, John H. Thomas, Samuel S. Sawyer and David Alexander was duly elected Ex. Committee for the ensuing year.

Moved and carried by Comrade Dr Ab Alexander that the Association take a recess and go to the Methodist Church in a boddy to hear the Rev. Mr Holden preach and meet after services at the church in the Court House and go to dinner in a boddy.

At 3 o'clock the Association was called to order by Comrade Jones, Chairman.

Moved and carried that the Ex. Committee appoint ladies in each one of the townships to solicit funds for the Old Veteran Soldiers Home near Raleigh, N. C.

The Association was addressed by Mr. Joseph Kinsey of Kinsey Sons, La Grange, Rev. Wm. Holden, and David Alexander.

The Committee on Resolutions submitted the following tribute of respect.

That while it has been the pleasure of him who rules the destiny of all men, to take from our midst since the last meeting our own member Comrade Levin Godwin.

- 1. Resolved that we bow in humble submission to the will of the living God who controls the destiny of all men.
- 2. That in Comrade Godwin we found a good soldier; one that was ever ready to perform any and all duties assigned him as a soldier.
- 3. That to the family of Comrade Godwin we say you have our sympathy and we commend them to the care of the God who rules the destiny of all creation.
- 4. That these resolutions be spread upon our minutes and that a page on our Minute Book be set apart to the memory of our beloved Comrade Levin Godwin.
- 5. That the Secretary of our Association send a copy of these resolutions to the family of our deceased comrade.

Addresses were made by Messrs. M. Majette, J. C. Meekins Sr., Rev. Mr. Savage, and Pres. Jones.

Upon the suggestion of Mr. Majette a list for the benefit of the Soldiers' Home at Raleigh was taken through the audience and resulted in the subscription of fifty one dollars for that purpose.

A vote of thanks to the ladies of the county and the people generally, for their kindness to the Association was unanimously adopted.

Adjourned to meet at the call of the President.

Speeches were made by the following gentlemen: Rev. Mr. Burns, J. D. Spruill, I. M. Meekins, Jos. E. Alexander, J. B. Leigh, Dempsey Spruill and J. C. Meekins Jr.

The Association unanimously passed a resolution thanking the people of Columbia and vicinity for their kind hospitality.

Appendix A – Service & Pension Records

This appendix only contains information from the service and pension records of members of the Tyrrell & Washington County Confederate Veterans Association who appear in the minutes of the Association. It does not include soldiers from these counties who died during the Civil War or survivors who were not members of the Association. This information is drawn primarily from muster rolls, medical records, prisoner of war records, discharges and pension records. Keep in mind that there may be gaps that vary by unit due to missing records such as muster rolls, which were recorded every two months in most cases. As an example, muster rolls for Company A, 32nd NC Infantry Regiment are missing for January – August 1864 and March – April 1865. Also keep in mind that the muster roll may only indicate the status of the soldier at the end of the period being reported. So, a soldier might be hospitalized and return to his unit during the reporting period of the muster roll and no mention of it made.

Unit designations used in the following extracts of service records are as shown on the service record cards. In some cases, these may not be totally accurate. For instance, these service record extracts show Company L of the 12th NC Infantry Regiment becoming Company A, 32nd NC Infantry Regiment in October 1861 because that is what the service cards show. In reality, Company L, 12th NC Infantry Regiment became part of the First Battalion, North Carolina Volunteers until the summer of 1862 when the 32nd NC Infantry Regiment was finally formed.

Muster rolls are the principal records found in service records. They may be missing for periods when a unit was actively campaigning. There are few to be found in any unit after 1864.

North Carolina soldier's pensions were paid at various rates depending on the level of disability and widow's pensions were based on the level of need. The laws governing these changed over time but were categorized as being the Acts of 1885 and 1901. The law of 1901 required all soldiers currently on the pension rolls to apply again. Most of the soldier's pension applications cited below were in 1901 or later and many were not the original applications, but subsequent applications which also attempted to increase the level of disability of the soldier. Apparently, the earlier applications upon which the pensions were initially approved no longer exist. It should be noted that a veteran had to be indigent to qualify for a pension.

ALEXANDER, ABNER (B.)

Enlisted November 4, 1861 in Martin County, NC in Captain Jno. H. Lanier's Company, NC Infantry. (This unit was redesignated as Company B, 42nd NC Infantry Regiment.) Mustered in on November 6, 1861 at Washington, NC. Present on Jan-Feb, Mar-Apr and May-Jun muster rolls in 1862. Appears on register of General Military Hospital No. 4, Wilmington, NC dated April 30, 1862 with dysenteria acuta and furloughed on May 2, 1862. Extended enlistment for two years. Company transferred to the 61st NC Infantry Regiment where it was Company H. Appears on the muster roll of this unit as a sergeant born in Martin County, NC, age 17, occupation school boy and 5 feet, 2 inches in height. Present until Jan-Feb 1863 muster roll when listed as absent, having been admitted to General Military Hospital No. 4, Wilmington, NC with debilitas on February 2, 1863 and sent home sick on a thirty-day furlough on February 22, 1863. Rejoined his unit at James Island, SC on April 18, 1863. Present on all subsequent muster rolls through Mar-Apr 1864. Promoted to second lieutenant on June 9, 1864. Listed as absent at the division infirmary, wounded on June 1, 1864 on the Sep-Oct 1864 muster roll. Present on the Nov-Dec 1864 muster roll.

ALEXANDER, B(ENJAMIN) V(ALENTINE)

Benjamin V. Alexander applied for a soldier's pension from North Carolina on June 8, 1901 in Tyrrell County, NC. At the time of application, he was 57 years of age and a resident of Columbia. Enlisted in Company H, 17th NC Infantry Regiment on or about February 10, 1861. (This is an apparent error, since the war had not started then, and should have been 1862.) Wounded by a gun shot that passed through his neck and out of his chest at Plymouth, NC on April 1, 1862. Discharged due to wound. On the rolls as a class four pensioner and it is recommended that he be made a class three pensioner. The earlier pension application apparently no longer exists. His widow, Mary Anne Alexander, applied for a widow's pension on July 3, 1922 in Tyrrell County, NC. At the time of application, she was 73 years of age and a resident of Jerry. A subsequent application was made on October 14, 1938 to advance Mary Anne Alexander, age 89, from a Class B pensioner to a Class A pensioner. Date of marriage was given as 1867. There are no service records in Company H, 17th NC Infantry Regiment for Benjamin V. Alexander. This could be due to the short period of time between his enlistment and his wounding. He was a brother of Nelson Alexander.

ALEXANDER, DAVID

Resident of Tyrrell County, NC and at age 24 enlisted at Norfolk, VA on October 4, 1861 in Company A, 32nd NC Infantry Regiment. Promoted to Corporal on June 6, 1862 and then to 1st Sergeant on December 25, 1862. Present on all muster rolls until hospitalized at General Hospital, Petersburg, VA for rubeola from July 2, 1862 to August 29, 1862. Present on all subsequent muster rolls until absent on furlough and returned since last muster on Nov-Dec 1863 muster roll. Present until captured at a location variously described as Mine Run, VA or Spotsylvania Court House, VA on May 10, 1864. Imprisoned at Point Lookout, MD on May 18, 1864 and then transferred to Elmira, NY on August 3, 1864. Released after taking the Oath of Allegiance at Elmira on June 23, 1865, at which time he is described as having a florid complexion, dark hair, blue eyes and being 6 feet, ½ inch in height.

ALEXANDER, NELSON

Resident of Tyrrell County, NC, where he enlisted at age 22 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Present on all existing muster rolls. Detailed to fish on bounty roll dated April 1, 1864 and sick in camp on the Jan-Feb 1865 muster roll. Deserted on March 30, 1865. Sent to Washington, DC where he took the Oath of Allegiance and transportation was furnished to Plymouth, NC. Nelson Alexander applied for an increase in his soldier's pension from North Carolina on June 8, 1901. At the time of

application, he was 60 years of age and a resident of Bay. Application states he enlisted in Company A, 32nd NC Infantry Regiment on May 16, 1861. Wounded in the ankle during the battle of the Wilderness in Virginia around May 11, 1864. Hospitalized for four weeks. Wounded again near the Rappahannock River in the left arm below the elbow and was hospitalized for six weeks. Since the war his left arm was broken and he has lost sight in his right eye. Also has a right inguinal hernia. On the rolls as a class four pensioner and it is recommended that he be made a class two pensioner. The earlier pension application apparently no longer exists.

ALEXANDER, WILLIAM E.

Although not mentioned in the minutes of the Confederate Veterans Association himself, his widow, Martha E. Alexander, is mentioned in several places, so his service record is included here. Resident of Tyrrell County, NC, where he enlisted at age 25 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Present on all existing muster rolls except May-Jun 1862 when absent sick in hospital at Petersburg, VA. Sick in quarters on Nov-Dec 1861 muster roll. Detailed to the division provost guard from April 1864 through February 1865. Surrendered at Appomattox Court House on April 9, 1865. His widow, Martha E. Alexander, applied for a widow's pension on July 5, 1909 in Tyrrell County, NC. At the time of application, she was 66 years of age and a resident of Columbia. Application states he had enlisted in Company A, 32nd NC Infantry Regiment on or about April 1861.

ALEXANDER, WILLIAM W.

Resident of Tyrrell County, NC, where he enlisted at age 26 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Detailed as ensign on October 20, 1861 and transferred to Company C of the 32nd NC Infantry Regiment on October 30, 1861, where he was detailed as color bearer. Present until muster roll of Mar-Apr 1862 when absent sick at Camp Benjamin. Sick in camp on the May-Jun 1862 muster roll and then absent sick in hospital at Petersburg, VA on Jul-Aug 1862 muster roll. On duty at City Barracks, Richmond, VA on regimental returns of November and December 1862. Present and detailed as acting hospital steward at barracks on Jan-Feb 1863 muster roll. Present on all existing muster rolls until admitted to Jackson Hospital, Richmond, VA on December 10, 1864 with diarrhea. Appears on a register of the Jackson Hospital, Danville, VA on April 8, 1865 with chronic diarrhea. William W. Alexander applied for a soldier's pension from North Carolina on July 20, 1903 in Tyrrell County, NC. He was 68 years of age and a resident of Columbia at the time of application and had enlisted in Company A, 32nd NC Infantry Regiment on May 16, 1861. He contracted typhoid fever in Virginia in 1862, causing bowel disease and kidney trouble from which he has never recovered. Recommended he be placed on pension roll in class four. His widow, Alice E. Alexander, applied for a widow's pension on July 3, 1916 in Tyrrell County, NC. At the time of application, she was 64 years of age and a resident of Columbia.

AMBROSE, D(AVID). B.

Enlisted at age 25 in Washington County, NC on March 29, 1862 in Company G, 17th NC Infantry Regiment (Second Organization). Described as a farmer born in Washington County, NC who was 5 feet, 11 inches in height. Present on all muster rolls until Jul-Aug 1863 when absent sick in hospital in Hamilton, NC. Then present until the muster roll of Nov-Dec 63 when absent on detached service in Washington County, NC after conscripts and deserters. Carried as absent sick in hospital in Wilmington, NC since February 26, 1864 on the muster roll of Jan-Feb 1864. There is no muster roll for Mar-Apr 1864, and then he is carried as absent on detached service as a teamster until the last of the existing muster rolls for Sep-Oct 1864. Receipt rolls for pay show he was still performing duties as a teamster on November 1 and December 1, 1864. No further records exist for this unit. David B. Ambrose applied for a soldier's pension from North Carolina on May 10, 1912 in Washington County, NC. At the time of application, he was 81 years of age. Enlisted in Company G, 17th NC Infantry Regiment on or about April 18, 1862. Was not wounded but suffers from severe rheumatism. Has been confined to a bed for over seven years and is unable to feed himself. His widow, Harriet A. Ambrose, applied for a widow's pension from North Carolina on July 6, 1914 in Washington County, NC. At the time of application, she was 73 years of age and a resident of Creswell.

ARMSTRONG, CHARLES H.

Resident of Tyrrell County, NC, where he enlisted at age 22 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present or accounted for until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861 and listed as absent, home on furlough. Present on all existing muster rolls until Nov-Dec 1863 when absent, sick in hospital. Admitted to General Hospital No. 9, Richmond, VA on December 5, 1863 and sent to Winder on December 6, 1863. Present on subsequent existing muster rolls until Jan–Feb 1865 when reported as absent without leave. Hospital records show he was admitted to General Hospital No. 9 again on May 29, 1864 and sent to Winder on May 30, 1864. Then appears on a hospital muster roll of the General Hospital, Camp Winder, Richmond, VA. Charles H. Armstrong applied for a soldier's pension from North Carolina on June 7, 1902 in Pasquotank County, NC. At the time of application, he was 64 years of age and a resident of Elizabeth City. He stated that he enlisted in Company A, 32nd NC Infantry Regiment on or about May 16, 1861. Not wounded but disabled by rheumatism contracted while in the service which has gotten worse over time. Approved for class four pension.

ARMSTRONG, THOMAS A.

Born in Tyrrell County and enlisted at age 18 at Columbia, NC in Battery B (Edenton Bell Battery), 3rd Battalion NC Light Artillery on February 4, 1862. Mustered in on March 27, 1862 at Camp Mangum, NC. Described as a farmer 5 feet, 3 ½ inches in height. Present on all battery muster rolls through Nov-Dec 1864 except absent in hospital at Wilmington on Sep-Oct 1863 muster roll. Appears on the register of General Military Hospital, No. 4, Wilmington, NC dated October 20, 1863 with abcessus and was returned to duty on December 4, 1863. Listed as deserted at Greensboro, NC on a muster roll of officers and men paroled in accordance with a Military Convention entered into on the 26th day of April, 1865, between General Joseph E. Johnston, Commanding Confederate Army, and Major General W. T. Sherman, Commanding United States Army in North Carolina. Roll is dated April 28, 1865 at Greensboro, NC and parole is effective May 1, 1865. Laura A. Armstrong, widow of Thomas A. Armstrong, applied for a widow's pension from North Carolina on April 7, 1923 in Tyrrell County, NC. At the time of application, she was 74 years of age and a resident of Columbia. She stated that her husband enlisted in Battery B, 3rd NC Battalion Light Artillery on or about May 15, 1861.

BARNES, THOMAS

Enlisted at age 19 on April 2, 1862 at Hamilton, NC in Company H, 17th NC Infantry Regiment (Second Organization). Described as a farmer born in Tyrrell County, NC who was 5 feet, 10 inches in height. Mustered in on June 17, 1862 at Camp Johnson, NC. Muster roll of May-Oct 1862 reports that he deserted on November 2, 1862. Pay receipt for service from November 2, 1861 to March 2, 1862 indicates he was also enlisted in the 17th NC Infantry Regiment (First Organization). This may be the same person as the William T(homas) Barnes who enlisted in Company B, 2nd NC Infantry Regiment (Union) on December 30, 1863 at Plymouth, NC. Being a farmer born in Tyrrell County, NC, age 22 at the time of enlistment and 5 feet, 10 inches in height, the descriptions match. Missing in action at Plymouth, NC on April 25, 1864. Present on subsequent muster rolls until he deserted at Carolina City on January 22, 1865. Described as having a light complexion, blue eyes and brown hair. Thomas Barnes applied for a soldier's pension from North Carolina on July 3, 1916 in Tyrrell County, NC. At the time of application, he was 74 years of age and a resident of Columbia, RFD #1. He stated that he enlisted in Company H, 17th NC Infantry Regiment on or about April 21, 1862. No wounds cited in application but disabled due to old age and privations suffered during the war, particularly neuralgia and hemorrhaging from the bowels.

BARNES, WILLIAM J.

Enlisted in Company A, 32nd NC Infantry Regiment on November 1, 1864 at Camp Holmes near Raleigh, North Carolina. Nov-Dec 1864 muster roll lists him as absent in hospital. Jan-Feb 1865 muster roll lists him as sick in hospital since returned. Admitted to the General Hospital, Farmville, VA on March 16, 1865 with acute dysentery. Paroled at Farmville, VA between April 11 and April 21, 1865. William J. Barnes applied for a soldier's pension from North Carolina on June 15, 1901 in Tyrrell County, NC. At the time of application, he was 63 years of age and a resident of Columbia. He stated that he enlisted in Company A, 32nd NC Infantry Regiment on or about October 22, 1864. Contracted measles and rheumatism at New Market, VA in December 1864, resulting in curvature of the spine and paralysis. Remained in the hospital until the close of the war and can't work. Recommended for class 2 pension.

BASNIGHT, LEMUEL

Resident of Tyrrell County, NC, where he enlisted on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present or accounted for until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Discharged by reason of disability on October 12, 1861. Lemuel Basnight applied for a soldier's pension from North Carolina on July 6, 1903 in Dare County, NC. At the time of application, he was 69 years of age and a resident of East Lake. He stated that he enlisted in Company A, Independent Battalion, NC Volunteers (became Company A, 32nd NC Infantry Regiment) on or about May 16, 1861. Suffered a double inguinal hernia while at the Fair Grounds, Norfolk, VA on or about September 1861 and was discharged. He also has paralysis of the left side and can no longer perform manual labor.

BASNIGHT, THOMAS

Resident of Tyrrell County, NC, where he enlisted at age 30 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Sick in quarters on Nov-Dec 1861 muster roll. Present until wounded and captured between July 1 and July 3 at Gettysburg, Pennsylvania. Hospitalized there and then transferred to De Camp General Hospital on David's Island in New York Harbor. Paroled at David's Island and transferred to City Point, Virginia for exchange on September 16, 1863. Home on furlough in Tyrrell County until he returned to duty after December 31, 1863. Deserted to Union forces on or about May 17, 1864 at Roanoke Island and confined at Fort Monroe, Virginia. Appears on a descriptive list of rebel deserters at Fort Monroe, VA as a resident of Tyrrell County, NC with brown eyes, gray hair, dark complexion and 6 feet, ³/₄ inches in height. Took the Oath of Amnesty and was released on May 20, 1864 and sent to Beaufort, NC. Thomas Basnight applied for an increase in his soldier's pension from North Carolina on June 22, 1901 in Tyrrell County, NC. At the time of application, he was 68 years of age and a resident of Columbia. He stated that he enlisted in Company A, 32nd NC Infantry Regiment on or about May 16, 1861. He was wounded in the right knee at Gettysburg, PA on July 2, 1863 and suffers from rheumatism and bowel disease. On the rolls as a class four pensioner and it is recommended that he be made a class two pensioner. The earlier pension application apparently no longer exists.

BATEMAN, HENRY H.

Not listed as a member of the Association, but mentioned as one of the veterans living in Tyrrell and Washington Counties for whom the Association received Crosses of Honor from the Pamlico Chapter of the United Daughters of the Confederacy in 1912. Enlisted at age 18 in Company H, 17th NC Infantry Regiment (2nd Organization) on December 24, 1863 at Hamilton for three years. Joined the Regiment on January 12, 1864 and present on Jan-Feb 1864 muster roll. Present until listed as absent at the infirmary since August 25, 1864 on August 31, 1864. Listed on the Sep-Oct 1864 muster roll as absent, furloughed from Winder Hospital on October 8, 1864 for 60 days. H. H. Bateman applied for a soldier's pension from North Carolina on July 31, 1911 in Washington County, NC. At the time of application, he was 66 years of age and a resident of Plymouth. He stated that he enlisted in Company G, 17th NC Infantry Regiment on October 1, 1863. Exhibits marked senile debility and has had a paralytic stroke which renders one side of his body of no practical use. Approved for class four pension. His widow, Ella A. Bateman, applied for a widow's pension on March 1, 1935 in Washington County, NC. At the time of application, she was 68 years of age and a resident of Plymouth. She stated that they were married on November 6, 1892 and that her husband had died on June 2, 1912. Approved April 4, 1935. She applied for an increase in pension on December 15, 1938. Described as having high blood pressure and mitral regurgitation, which keeps her from doing any work. Approved for class A pension.

BATEMAN, J(AMES) I(REDELL)

Enlisted at age 17 in Washington County, NC on April 16, 1862 in Company G, 17th NC Infantry Regiment (Second Organization) but was discharged when the company mustered in at Camp Mangum on May 29, 1862. Described as a farmer born in Washington, NC and 5 feet, 8 inches in height. James I. Bateman applied for a soldier's pension from North Carolina on July 1, 1912 in Washington County, NC. At the time of application, he was 67 years of age and a resident of Creswell. He stated that he enlisted in Company G, 17th NC Infantry Regiment on or about April 18, 1862. Not wounded but suffering from chronic Bright's Disease for several years and recently developed problems with his testicles. He is unable to work. His widow, Ida S. Bateman, applied for a widow's pension from North Carolina on May 23, 1925 in Washington County, NC. At the time of application, she was 52 years of age and a resident of Creswell. Applied again on November 4, 1938 at Plymouth, NC to have her pension increased from class B to class A due to total disability. She was 65 years of age at the time of application and had married James I. Bateman in 1891.

BATEMAN, JOHN

Resident of Tyrrell County, NC who enlisted in Company A, 32nd NC Infantry Regiment at age 20 at Portsmouth, Virginia on November 15, 1861. Present or accounted for until he was discharged due to chronic sickness on June 6, 1862. His widow, Martha A. Bateman, applied for a widow's pension from North Carolina on April 26, 1924 in Pasquotank County, NC. At the time of application, she was 66 years of age and a resident of Elizabeth City. Her husband had enlisted in Company A, 32nd NC Infantry Regiment on or about November 15, 1861.

BATEMAN, JOSEPH

Joseph Bateman applied for a soldier's pension from North Carolina on July 5, 1915 in Tyrrell County, NC. At the time of application, he was 70 years of age and a resident of Columbia. He stated that he enlisted in the Ranger Company of Capt. William Henry Spencer on or about December 1863. He was never wounded. Due to feebleness of old age he can't earn a living and the income from his wife's property is not sufficient to support him. His widow, Frances Bateman, applied for a widow's pension on July 4, 1927. She states in the application that they were married October 23, 1866 and that her husband died February 11, 1921. There are no service records for members of William H. Spencer's company of rangers.



BEASLEY, W(ILLIAM) F(ESSENDEN)

Living in Plymouth, NC in the 1860 census and a cadet at a military academy at the start of the war, at age 16 he was paid \$19.99 on August 15, 1861 by Major A. M. Lewis for service as a drillmaster from July 25, 1861 to August 13, 1861. Paid \$70 on June 11, 1862 by Major A. M. Lewis for service as Drillmaster, 48th N. C. T. from April 8, 1862 to June 11, 1862. Pay voucher states discharged this day. Appears on an August 1864 roster of the 48th Regiment, North Carolina Volunteers who were organized April 9, 1862 and mustered into Confederate service on May 5, 1862. At that time, he was 3rd Lieutenant of Company H, 48th Regiment, North Carolina Infantry and listed as having entered state service on March 8, 1862, Confederate service on August 6, 1862 and having been elected 3rd Lieutenant on the same day. He was promoted to 2nd Lieutenant a week later. Absent on detached duty on the Sep-Oct 1862 muster roll. In the Fall and early winter, 1862 the regiment was in the battles of Sharpsburg and Fredericksburg, suffering 571 casualties, including 181 killed or mortally wounded. Admitted to General Hospital Number 24 on November 5, 1862 with herpes and discharged November 7, 1862. Regimental return of December 1862 lists him as absent, wounded at hospital. Company muster roll of Jan-Feb 1863 lists him as absent, wounded at Fredericksburg and home on furlough. Casualty lists state that he was wounded severely in the thigh on or about December 13, 1862. Promoted to 1st Lieutenant on February 10, 1863, shortly after his eighteenth birthday. Present on company muster roll of Mar-Apr 1863. May-Jun 1863 muster roll lists him as absent, sick since May 25, 1863. On July 20, 1863 he was assigned as Assistant Enrolling Officer, 2 Congressional District of North Carolina because of disability from wounds for field service. Wound in the left thigh on December 13, 1862 resulted in peritonitis and he was admitted to General Hospital Number 4, Richmond, VA on October 14, 1863, from which he was furloughed on October 17, 1863 for 30 days with a destination of Hillsboro, NC. Ordered to report to General L. S. Baker for assignment on November 3, 1863, being unfit for field service. Listed as absent, on detached service since November 3, 1863 by order of the Secretary of War on the Mar-Apr 1864 muster roll of Company H, 48th Regiment, North Carolina Infantry. On June 5, 1864 he was elected Major of the 5th Battalion, Junior Reserves, consisting of 321 officers and boys under age 18. At age 19, he was one of the youngest Field Officers in the Confederacy at that time. In July the 2nd and 5th Battalions, Junior Reserves consolidated, becoming designated as Anderson's Battalion, Junior Reserves. In late 1864 two companies were added and the unit was redesignated the 2nd Regiment, North Carolina Junior Reserves, with Beasley being promoted to Lieutenant Colonel. Few records exist of Beasley's service after that, but the regiment fought in the battles of Wyse's Fork March 8-9, 1865 and Bentonville March 19-21. Paroled in May 1865, a patient a General Hospital Number 11 in Charlotte, NC at the time.

BEST, LEMUEL B.

Resident of Tyrrell County, NC, where he enlisted at age 33 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Listed as absent, detailed to cut logs for winter quarters, on the Sep-Oct 1861 muster roll. Present until the muster roll of Sep-Oct 1863 when listed as wounded and in the hospital at Richmond, VA on October 7, 1863. Appears on the register of the General Hospital, Charlottesville, VA as being admitted on October 18, 1863 and returned to duty on November 24, 1863. Promoted to Corporal on December 1,

1863. Captured at a location variously described as Mine Run, VA or Spotsylvania Court House, VA on May 10, 1864 and imprisoned at Point Lookout, MD on May 18, 1864. Transferred to Elmira, NY on August 3, 1864 and released there on June 27, 1865 after taking the Oath of Allegiance, at which time he was described as a resident of Plymouth, NC, having a florid complexion, dark hair, blue eyes and being 5 feet, 10 inches in height.

BLOUNT, LEVI

Not listed as a member of the Association, but mentioned as one of the veterans living in Tyrrell and Washington Counties for whom the Association received Crosses of Honor from the Pamlico Chapter of the United Daughters of the Confederacy in 1912. Enlisted November 1, 1862 in Company B, 3rd NC Cavalry Regiment (Old Company G, 41st Regiment NC State Troops) at Beaufort County for the war. Muster rolls vary as to date of enlistment to include October 15, 1862, September 16, 1862 and September 1, 1862. All muster rolls other than the initial one state that he enlisted in Washington County, NC. Listed as present on the Nov-Dec 1862 muster roll. Listed as present on muster rolls for November 1863 through February 1864. Absent with no horse on the Mar-Apr 1864 muster roll. Absent, left at Kinston, NC by order of Col Baker with no horse on May-Jun 1864 muster roll. Absent at Kinston, no horse and bounty due \$50 on the Jul-Aug 1864 muster roll. Absent on horse detail and returned to company from Kinston, NC on October 4, 1864 on the Sep-Oct 1864 muster roll. Appears on clothing receipts on October 1 and December 31, 1864. No further record.

BRICKHOUSE, DOCTRINE D.

Born in Tyrrell County and enlisted at age 20 at Columbia, NC in Battery B (Edenton Bell Battery), 3rd Battalion NC Light Artillery on February 4, 1862. In hospital on muster in roll dated March 27, 1862 at Camp Mangum, NC. Described as a farmer 5 feet, 6 ½ inches in height. Present on all battery muster rolls through Nov-Dec 1864. Present on a muster roll of officers and men paroled in accordance with a Military Convention entered into on the 26th day of April, 1865, between General Joseph E. Johnston, Commanding Confederate Army, and Major General W. T. Sherman, Commanding United States Army in North Carolina. Roll is dated April 28, 1865 at Greensboro, NC and parole is effective May 1, 1865.

BRICKHOUSE, FRANKLIN L.

Born in Tyrrell County and enlisted at age 23 at Columbia, NC in Battery B (Edenton Bell Battery), 3rd Battalion NC Light Artillery on February 4, 1862. Mustered in at Camp Mangum, NC on March 27, 1862. Described as a farmer 5 feet, 11 inches in height. Present on all battery muster rolls through Nov-Dec 1864. Promoted to corporal sometime between November 1862 and March 1863. Captured at Town Creek on February 28, 1865 and imprisoned at Point Lookout, MD on March 28, 1865. Released at Point Lookout on June 23, 1865. Listed as captured at Town Creek on a muster roll of officers and men paroled in accordance with a Military Convention entered into on the 26th day of April, 1865, between General Joseph E. Johnston, Commanding Confederate Army, and Major General W. T. Sherman, Commanding United States Army in North Carolina. Roll is dated April 28, 1865 at Greensboro, NC and parole is effective May 1, 1865.

BURNS, J(OSEPH) L., REV.

Enlisted at age 32 on May 15, 1861 in Vicksburg, MS in Captain D. N. Moody's Company, Mississippi Volunteers, which subsequently became Company A, 21st MS Infantry Regiment. Mustered in at Richmond City, VA on June 5, 1861. Present but sick in quarters on Jul-Aug 1861 muster roll. Appears on a register of Clopton Hospital, Richmond, VA on October 7, 1862 as having been furloughed for 30 days, but present on all existing muster rolls until Sep-Oct 1863, when listed as absent, wounded on September 20, 1863. Listed in the same status on all existing muster rolls after that. A record of his unit dated March 4, 1865 near Richmond, VA says he was born in North Carolina, is a resident of Skipwith Landing, his occupation is overseer, he is single and is disabled, his right arm having been amputated when wounded on September 20, 1863.

CAHOON, A. A.

This name only appears as a member present at the roll call of a meeting of the association on August 30, 1906. A survey of census records results in three possibilities, Allen Cahoon, Abel Cahoon and Ashby Cahoon. Ashby Cahoon can be eliminated because he died in 1900. Allen Cahoon died in 1908 but no service records could be located for him. A death date for Able Cahoon could not be found but service records were found, as follows. Resided in Hyde County and enlisted in Company H, 33rd NC Infantry Regiment at Camp Holmes, near Raleigh, NC, on October 2, 1864 at age 25. Present or accounted for until furloughed for sixty days on February 20, 1865.

CAHOON, DOCTINE

Enlisted at Camp Lee in Battery B (Edenton Bell Battery), 3rd Battalion NC Light Artillery on April 14, 1862. Present on all battery muster rolls through Nov-Dec 1864 except listed as being on detached service at Kenansville, NC on the May-Jun 1863 muster roll. Present on a muster roll of officers and men paroled in accordance with a Military Convention entered into on the 26th day of April, 1865, between General Joseph E. Johnston, Commanding Confederate Army, and Major General W. T. Sherman, Commanding United States Army in North Carolina. Roll is dated April 28, 1865 at Greensboro, NC and parole is effective May 1, 1865.

CAHOON, JESSE S.

Resident of Tyrrell County, NC who enlisted in Company A, 32nd NC Infantry Regiment at age 23 at Portsmouth, VA on November 12, 1861. Present on the muster rolls from Nov-Dec 1861 to Nov-Dec 1863 except in Mar-Apr 1863 when listed as absent on furlough of 18 days commencing 30 April. Also listed as sick in quarters in Nov-Dec 1861 and was admitted to Chimborazo Hospital No. 2, Richmond, VA for diarrhea on August 22, 1862. Captured at a location variously described as near Mine Run, VA or Spotsylvania Courthouse, VA on May 10, 1864 and listed on muster rolls from Sep-Oct 1864 to Jan-Feb 1865 as absent, prisoner of war. Imprisoned on May 18, 1864 at Point Lookout, MD and transferred to Elmira, NY on August 3, 1864. Released at Elmira after taking the Oath of Allegiance on June 27, 1865, at which time he is listed as a resident of Plymouth, NC and described as having a florid complexion, dark hair, blue eyes and being 5 foot 8 inches in height. Jesse Cahoon applied for a soldier's pension from North Carolina on June 29, 1901 in Tyrrell County, NC. At the time of application, he was 60

years of age and a resident of Gum Neck. He stated that he enlisted in Company A, 32nd NC Infantry Regiment on May 16, 1861. Wounded by a shell in the left hip at Gettysburg, PA on July 3, 1863 and suffers from a left inguinal hernia. On the rolls as a class four pensioner and it is recommended that he be made a class two pensioner. The earlier pension application apparently no longer exists. His widow, Nat Cahoon, applied for a widow's pension on July 4, 1921 in Tyrrell County, NC. At the time of application, she was 70 years of age and a resident of Columbia.

CAHOON, J(ASPER) STANLEY

Resident of Tyrrell County, NC, and enlisted at age 20 on October 20, 1861 at Portsmouth, VA in Company A, 32nd NC Infantry Regiment. Present on all muster rolls until May-Jun 1862 when absent, sick in hospital at Petersburg, VA. Present on all subsequent existing muster rolls until captured at a location variously described as Mine Run, VA or Spotsylvania Court House, VA on May 10, 1864 and imprisoned at Point Lookout, MD on May 18, 1864. Transferred to Elmira, NY on August 3, 1864 and released there on June 27, 1865 after taking the Oath of Allegiance, at which time he was described as a resident of Plymouth, NC, having a dark complexion, dark hair, dark eyes and being 5 feet, 5 inches in height. J. S. Cahoon applied for a soldier's pension from North Carolina on June 29, 1901 in Tyrrell County. He was 59 years of age and a resident of Columbia who had enlisted in Company A, 32nd NC Infantry Regiment on May 16, 1861. He was wounded at Spotsylvania Court House, VA on May 10, 1864 and lost his left eye. The wound was to the left elbow, disabling his left arm. In addition, he can see little with his right eye. On the rolls as a class four pensioner and it is recommended that he be made a class two pensioner. The earlier pension application apparently no longer exists. His widow, Eliza Jane Cahoon, applied for a widow's pension on June 27, 1921 in Norfolk County, VA. She was 77 years of age and a resident of Columbia, NC.

CARAWAN, W(ILLIAM) R(UEL), REV.

Enlisted October 1, 1861 as a sergeant in Company H, 33rd NC Infantry Regiment. Promoted to 1st Sergeant on January 15, 1863. Promoted to 2nd lieutenant on August 2, 1863. Mustered out March 15, 1865. William R. Carawan applied for a soldier's pension from North Carolina on July 24, 1906 in Tyrrell County, NC. At the time of application, he was 64 years of age and a resident of Columbia. He stated that he enlisted in Company H, 33rd NC Infantry Regiment on or about October 17, 1861. Wounded in the right arm at Chancellorsville, VA in May 1863 and wounded in the left upper thigh in a skirmish with dismounted cavalry. Now disabled by old age and kidney and lung problems. His widow, Minerva Carawan, applied for a widow's pension on June 25, 1921 in Tyrrell County, NC. At the time of application, she was 71 years of age and a resident of Columbia.

CHAPLIN, S(PENCER) R.

Enlisted July 27, 1861 at Bellevue, NC in Company G, 2nd NC Cavalry Regiment. Present on muster rolls from Jan-Feb 1862 to Jan-Feb 1863 when absent on detail to procure a fresh horse. Absent on detail on the Mar-Apr 1863 muster roll. Captured at a location variously described as Williamsport, MD or Falling Waters, VA on July 16, 1863. Imprisoned on July 18, 1863 at the Old Capitol Prison, Washington, DC and appears on prison rolls on July 23, 1863, August 1, 1863

and August 8, 1863. Took the Oath of Allegiance on December 13, 1863 at Washington, DC, at which time he is described as a resident of Tyrrell County, NC, of dark complexion, dark hair, dark eyes and 6 feet in height. Sent north on December 17, 1863.

CHESSON, HEZEKIAH

Enlisted at age 18 in Plymouth, NC on August 2, 1861 in Company B, 1st NC Cavalry Regiment. Present on Nov-Dec 1861 muster roll, then absent, captured by the enemy on February 2, 1862 while on outpost duty. Carried as absent, captured through the Sep-Oct 1862 muster roll. Present on detached service on the Nov-Dec 1862 muster roll, so he must have been exchanged. Present on all subsequent muster rolls through Sep-Oct 1864. No further record. Hezekiah Chesson applied for a soldier's pension from North Carolina on July 5, 1912 in Washington County, NC. At the time of application, he was 69 years of age and a resident of Roper. He stated that he enlisted in Company B, 1st NC Cavalry Regiment on or about August 3, 1861. Not wounded in service but is not physically able to do manual labor to support himself. His widow, Ruth S. Chesson, applied for a widow's pension on April 30, 1923 in Washington County, NC. At the time of application, she was 73 years of age and a resident of Oak Ridge. There is also an application dated June 14, 1923 in Bertie County, NC. At the time of this application, she was 72 years of age and a resident of Oak City, Martin County, NC.

CHESSON, W(ILLIAM) R.

Enlisted on May 3, 1861 at Plymouth, NC in Company H, 17th NC Infantry Regiment (First Organization). Mustered in as a corporal on June 20, 1861 at Beacon Island and mustered out on March 20, 1862 at Williamston, NC. Promoted to 2nd lieutenant on November 2, 1861. Enlisted again at age 20 at Hamilton, NC in Company H, 17th NC Infantry Regiment (Second Organization) on April 2, 1862. Mustered in as a 3rd Lieutenant on June 17, 1862 at Camp Johnson. Described as a farmer born in Washington County, NC who was 5 feet, 10 ½ inches in height. Promoted to 2nd lieutenant in July or August of 1863. Present until the Jul-Aug 1863 muster roll when listed as absent sick since 13th instant. Then present until the Sep-Oct 1864 muster roll when absent, sent to hospital in Petersburg, VA on September 27, 1864. Admitted to General Hospital, Petersburg, VA on September 28, 1864 with chronic diarrhea and sent to Danville on September 30, 1864. Admitted to Pettigrew General Hospital No. 13, Raleigh, NC for chronic diarrhea on October 3, 1864 and discharged on November 22, 1864. No further record.

CLOUGH, J(OSEPH) A(SHBY) (SPENCE)

J. A. Clough was added as a member of the Confederate Veterans Association at a meeting on August 7, 1902. Appears on no rosters with associated unit information since none were created after 1901. A survey of census data shows that the only person this could be is Joseph A. Clough, born in Tyrrell County on December 20, 1846, the son of Rowan and Clarkey (Pritchett) Clough. He died on April 21, 1905 in Tyrrell County, which explains why he only appears in the records one time. No service records can be found for him. Because of his age, he would not have enlisted until the end of the war, when few records were created, or he could have been a member of the partisan rangers for whom few, if any, records exist. But it is obvious he did serve since he was admitted to the association and was a local man whom all would have known.

COLLINS, ARTHUR C.

A son of Josiah Collins III, he enlisted April 29, 1861 at age 19 at Edenton, NC in Company M, 1st Regiment, North Carolina Volunteers. Mustered into service of the state on June 25, 1861 at Yorktown, VA and mustered into service of the Confederate States at Ship Point, VA on August 31, 1861. Present on all muster rolls until the regiment disbanded and returned to North Carolina on November 12, 1861. Many of the men transferred to the 11th North Carolina Infantry Regiment but it appears he did not since he only appears on a roll of honor of this regiment. Appears on special requisitions as a lieutenant from February through November 1863 in Company F, Colonel Peter Mallett's Battalion, North Carolina Camp Guards (Camp Holmes). Listed variously in Association rosters as being in Independent Troops or Independent Cavalry. No further record.

COLSTON, WILLIAM G.

Resident of Maryland and enlisted in Tyrrell County, NC at age 21 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Absent on detail cutting logs for mess rooms on muster roll for Nov-Dec 1861. Then present and accounted for on all existing muster rolls through February 1865. On detail as a teamster during that entire time. North Carolina pension records say he was wounded at Petersburg, VA on October 10, 1864. William G. Colston applied for a soldier's pension from North Carolina on June 12, 1901 in Tyrrell County, NC. At the time of application, he was 56 years of age and a resident of Columbia. He stated that he enlisted in Company A, 32nd NC Infantry Regiment on or about May 16, 1861. Wounded on inside of right ankle and received shell wound that destroyed right eye at Winchester, VA and Petersburg, VA on or about October 10, 1864. Totally deaf in left ear and nearly so in right ear. Also has neuralgia of bowels, back and left hip. On the rolls as a class four pensioner and it is recommended that he be made a class two pensioner. County pension board recommends class four. The earlier pension application apparently no longer exists. His widow, Mary A. Colston, applied for a widow's pension on June 24, 1920 in Pasquotank County, NC. At the time of application, she was 73 years of age and a resident of Elizabeth City.

COMBS, ABNER A(LEXANDER)

Born in Tyrrell County and enlisted at age 23 at Columbia, NC in Battery B (Edenton Bell Battery), 3rd Battalion NC Light Artillery on February 4, 1862. Mustered in as a corporal at Camp Mangum, NC on March 27, 1862. Described as a farmer 5 feet, 6 1/2 inches in height. Present on all battery muster rolls through Nov-Dec 1864. Listed as quartermaster sergeant commencing with the Mar-Apr 1863 muster roll. Appears on a register of General Military Hospital, No. 4, Wilmington, NC dated November 4, 1863 being treated for scabies and was discharged on November 7, 1863. Listed as present on a muster roll of officers and men paroled in accordance with a Military Convention entered into on the 26th day of April, 1865, between General Joseph E. Johnston, Commanding Confederate Army, and Major General W. T. Sherman, Commanding United States Army in North Carolina. Roll is dated April 28, 1865 at Greensboro, NC and parole is effective May 1, 1865. Abner A. Combs applied for a soldier's pension from North Carolina on September 21, 1906 in Tyrrell County. He was 68 years of age and a resident of Gum Neck, Tyrrell County at the time, who had enlisted in Battery B, 3rd Battalion NC Light Artillery on February 4, 1862. He had received no wounds but was disabled by old age and was deaf due to artillery fire. One arm was also impaired due to a recent medical procedure. There is also an incomplete, undated pension application under the laws of 1925. He died on June 26, 1930 in Tyrrell County.

COMBS, THOMAS T.

Resident of Tyrrell County, NC, where he enlisted at age 30 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Promoted to Corporal on December 15, 1862. Present on the muster rolls of Company A, 32nd Infantry Regiment from Nov-Dec 1861 through Nov-Dec 1863 except for being listed in Mar-Apr 1863 as absent, sick in hospital in Wilson, NC, having left camp on April 20, 1863. Also hospitalized on August 22, 1862 at Chimborazo Hospital No. 2, Richmond, VA for bronchitis and at the CSA General Hospital in Charlottesville, VA on December 25, 1863 and discharged on December 30, 1863 for Int. Fev. Quo. Captured on May 10, 1864 at a location variously described as Mine Run, VA or Spotsylvania Court House, VA and listed on muster rolls from Sep-Oct 1864 to Jan-Feb 1865 as absent, prisoner of war. Imprisoned on May 18, 1864 at Point Lookout, MD and transferred to Elmira, NY on August 3, 1864. Released at Elmira after taking the Oath of Allegiance on June 14, 1865, at which time he is listed as a resident of Plymouth, NC and described as having a florid complexion, auburn hair, blue eyes and being 5 foot 7 inches in height. North Carolina pension records indicate he was wounded at Gettysburg, Pennsylvania on July 3, 1863. Thomas T. Combs applied for a soldier's pension from North Carolina on June 29, 1901 in Tyrrell County, NC. At the time of application, he was 66 years of age and a resident of Columbia. He stated that he enlisted in Company A, 32nd NC Infantry Regiment on May 16, 1861. Wounded in the neck at Gettysburg, PA on July 3, 1863, causing a cancer on the left side of the back of the neck. Also suffers from disease of lungs contracted due to exposure. On the rolls as a class two pensioner and it is recommended that he remain a class two pensioner. The earlier pension application apparently no longer exists.

COMSTOCK, L(OUIS) B.

Enlisted at age 20 on May 7, 1862 in Washington County, NC in Company G, 17th NC Infantry Regiment (Second Organization). Mustered in at Camp Mangum on May 29, 1862. Described as being born in Washington County, NC, a farmer who was 5 feet, 11 inches in height. Present on muster rolls until Nov-Dec 1862 when listed as absent, sick in hospital at Wilson, NC. Present on subsequent muster rolls until May-Aug 1864 when absent sick and wounded July 3, 1864. Carried as absent, sick on sixty-day furlough commencing October 10, 1864 on the Sep-Oct 1864 muster roll. Appears on a muster roll of the 6th Division, General Hospital Camp Winder, Richmond, VA on August 31, 1864. No further record. L. B. Comestalk applied for a soldier's pension from North Carolina on June 29, 1885 in Washington County, NC. At the time of application, he was 44 years of age and a resident of Creswell. He stated that he enlisted in Company G, 17th NC Infantry Regiment on or about May 15, 1862. Wounded in the palm of the hand and left thigh at Petersburg, VA on July 3, 1864 and was retired from the service. Bullet in left thigh passed out near the rectum. Hand is largely deformed. L. B. Comstock applied for a soldier's pension from North Carolina again, as was required by law, on July 1, 1901 in Washington County, NC. At the time of application, he was 60 years of age and a resident of Cherry. He stated that he enlisted in Company G, 17th NC Infantry Regiment on or about May 20, 1862. Wounded as stated in previous application. His widow, Dorcas Comstock, applied for a widow's pension from North Carolina on July 10, 1913 in Washington County, NC. At the time of application, she was 67 years of age.

COOPER, JESSE L.

Born in Tyrrell County and enlisted at age 22 at Columbia, NC in Battery B (Edenton Bell Battery), 3rd Battalion NC Light Artillery on February 4, 1862. Mustered in on March 27, 1862 at Camp Mangum, NC. Described as a farmer 5 feet, 10 inches in height. Present on all battery muster rolls through Nov-Dec 1864 except absent on furlough on Jul-Aug 1863 muster roll. Listed as sick on Sep-Oct 1864 muster roll. Promoted to corporal on March 11, 1863. Present on a muster roll of officers and men paroled in accordance with a Military Convention entered into on the 26th day of April, 1865, between General Joseph E. Johnston, Commanding Confederate Army, and Major General W. T. Sherman, Commanding United States Army in North Carolina. Roll is dated April 28, 1865 at Greensboro, NC and parole is effective May 1, 1865. J. L. Cooper applied for a soldier's pension from North Carolina on July 3, 1911 in Tyrrell County, NC. At the time of application, he was 71 years of age and a resident of Columbia. He stated that he enlisted September 1, 1861 in Battery B, 3rd Battalion, NC Light Artillery. Slightly wounded in both thighs by a bomb shell at White Hall, NC in November 1863. Totally disabled both mentally and physically. Suffering from nephritis, senile debility and impaired eyesight. Disallowed, probably due to having too much property. Applied again on 28 June, 1915 in Tyrrell County, NC. At the time of application, he was 75 years of age and a resident of Columbia. He stated that he enlisted September 1, 1861 in Battery B, 3rd Battalion, NC Light Artillery. Wounded in both thighs at White Hall, Lenoir County in 1863. Totally disabled for work of any kind due to disease and old age and has no property. Application approved. His widow, Mary M. Cooper, applied for a widow's pension on July 1, 1918 in Tyrrell County, NC. At the time of application, she was 68 years of age and a resident of Columbia.

DAVENPORT, H(EZEKIAH) H.

Enlisted at age 20 on May 3, 1862 in Washington County, NC in Company G, 17th NC Infantry Regiment (Second Organization). Mustered in at Camp Mangum on May 29, 1862. Described as a farmer born in Washington County, NC who was 5 feet, 10 inches in height. Present on muster rolls until May-Aug 1864 when absent on detached service as a pilot for Colonel Wortham in Washington County. Present on Sep-Oct 1864 muster roll and listed as having rejoined the company on September 13, 1864 as a sharpshooter. Captured near Kinston, NC on March 10, 1865 and imprisoned at Point Lookout, MD on March 16, 1865. Released on June 12, 1865 after taking the Oath of Allegiance, at which time he was described as a resident of Washington County, NC with dark complexion, brown hair, light hazel eyes and 5 feet, 11 inches in height. Martha Ellen Davenport, widow of Hezekiah H. Davenport, applied for a widow's pension from North Carolina on July 3, 1909 in Tyrrell County, NC. At the time of application, she was 67 years of age and a resident of Columbia. Her late husband, Hezekiah H. Davenport, had served in Company G, 17th NC Infantry Regiment.

DAVENPORT, WILSON S.

Resident and native of Tyrrell County, NC, where he enlisted at age 21 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Listed as sick in quarters on May 16–Aug 31 muster roll. Promoted to Corporal on January 23, 1862. Present until discharged due to disability at Camp Drury, VA on June 7, 1862. Discharge describes him as six feet tall, light complexion, blue eyes & light hair. Wilson S. Davenport applied for a soldier's pension from North Carolina on June 19,1901 in Tyrrell County, NC. At the time of application, he was 60 years of age and a resident of Columbia. He stated that he enlisted in Company A, 32nd NC Infantry Regiment on May 16, 1861. While at Norfolk, VA in the Spring of 1862 he contracted lung and bowel disease for which he was discharged for general disability. He has never recovered.

DOWNING, T(HOMAS) S.

Enlisted in Capt. Lee's Company, Alabama Light Artillery (Montgomery Blues) in July 1864 at Plymouth, NC. Listed as absent with section at Little Bethel, NC on the Jul-Aug 1864 muster roll. Also appears on a receipt roll of this unit for clothing in the 3rd quarter of 1864. No further record. Both rosters of the association upon which he appears list him as dead. On Find-a-Grave Thomas S. Downing is cited as being born in Tyrrell County in 1847 and died in Tyrrell County in 1892. Based on this, he would have been about 17 years of age when he enlisted.

DUNSTON, JOHN

Born in Tyrrell County and enlisted at age 32 at Columbia, NC in Battery B (Edenton Bell Battery), 3rd Battalion NC Light Artillery on February 4, 1862. Mustered in on March 27, 1862 at Camp Mangum, NC. Described as a farmer 5 feet, 9 inches in height. Present on all battery muster rolls through Nov-Dec 1864 except absent on furlough on Sep-Oct 1863 muster roll. Present on a muster roll of officers and men paroled in accordance with a Military Convention entered into on the 26th day of April, 1865, between General Joseph E. Johnston, Commanding Confederate Army, and Major General W. T. Sherman, Commanding United States Army in North Carolina. Roll is dated April 28, 1865 at Greensboro, NC and parole is effective May 1, 1865.

ELLIOTT, M(ACK) G.

Enlisted at age 18 at Polenta, Halifax County, NC on June 19, 1861 in Company B, 1st NC Cavalry Regiment. Present on muster rolls until Nov-Dec 1862 when absent, captured by the enemy on November the 5th. Present on muster rolls from Jan-Feb 1863 to Jul-Aug 1863 when listed as absent on detached service to North Carolina for a horse on August 27th. Present on subsequent muster rolls until Sep-Oct 1864 when absent on forage detail. Present on Nov-Dec 1864 muster roll. No further service records. Mack G. Elliott applied for a soldier's pension from North Carolina on June 2, 1901 in Tyrrell County, NC. At the time of application, he was 58 years of age and residing in Columbia. He stated that he enlisted in Company B, 1st NC Cavalry Regiment on or about June 1, 1861. Wounded in the left foot at Brandy Station, VA on June 10, 1863. Unable to work due to night blindness and disease of the bowels and lungs. On the rolls as a class four pensioner and it is recommended that he be made a class three pensioner. The earlier pension application apparently no longer exists. His widow, Caroline V. Elliott, applied for a widow's pension in June 1922 in Tyrrell County, NC. At the time of application, she was 73 years of age and a resident of Columbia.

EVERITT, JAMES (H.)

Enlisted at age 21 on August 2, 1861 at Plymouth, NC in Company B, 1st NC Cavalry Regiment. Present on muster rolls until Jan-Feb 1862 when absent, captured by the enemy on February 22nd. A regimental return of February 1862 says he was captured while on outpost duty. Listed as captured until Jan-Feb 1863 when present again and remained present through Sep-Oct 1864. No further service records. Applied at age 65 on December 23, 1901 for admission to the North Carolina Soldier's Home at Raleigh, NC and admitted on February 23, 1902. Enlisted in Washington County, NC on August 2, 1861 in Company B, 1st NC Cavalry Regiment as a private and surrendered at the close of the war. Described as an unmarried farmer of light complexion and 5 feet, 7 inches in height. His nearest relative is Mrs. Joseph Bateman of Columbia, Tyrrell County, NC. Applied for a soldier's pension from North Carolina on July 16, 1904 in Washington County, NC. He was age 68 and a resident of Roper, NC who enlisted in Company B, 1st NC Cavalry Regiment in April 1861. His feet were frost bitten during service and he now has rheumatism that prevents normal labor. Doctor statement cites problems with skin on feet and senile disability.

FOREMAN, C(LAUDIUS) T(ATEM)

Enlisted at age 18 at Lynnhaven Beach, VA on June 20, 1861 in Company L, 5th VA Cavalry Regiment. Mustered into service at Lynnhaven Beach on August 1, 1861. Present on muster rolls through Jan-Feb 1862 when it was noted that his enlistment was extended for two years. Muster roll of Mar-Apr 1862 says transferred to Company B on April 8, 1862. Appears on a muster-in roll of Captain John F. Cooper's Company, Burroughs' Battalion, Virginia Cavalry dated May 1, 1862 at Sewell's Point where it is noted that he was transferred from the Chesapeake Cavalry on April 5, 1862. This company subsequently became Company A, 14th Battalion Virginia Cavalry until September 1862 when the 14th and 15th Battalions, Virginia Cavalry were consolidated into the 15th VA Cavalry Regiment, in which it became Company F. Present on existing muster rolls from Mar-Apr 1863 to Mar-Apr 1864 when listed as absent on detached service. Horse killed at battle of Brandy Station, VA on October 11, 1863. Admitted to General Hospital No. 9, Richmond, VA on August 6, 1864 and sent to Stuart Hospital, Richmond, VA on April 7, 1864 where he was admitted with febris intermittens. Returned to duty on August 22, 1864. Name appears on a list of paroled prisoners of war from Company G, 5th VA Cavalry Regiment at Norfolk, VA on April 24, 1865.

GARRETT, DANIEL

Not listed as a member of the Association, but mentioned as one of the veterans living in Tyrrell and Washington Counties for whom the Association received Crosses of Honor from the Pamlico Chapter of the United Daughters of the Confederacy in 1912. Enlisted on March 21,

1862 at Plymouth in Company G, 17th NC Infantry Regiment for three years and mustered into service at Camp Mangum, NC on May 29, 1862. Described as born in Washington, NC, age 21, occupation sailor and five feet, five inches in height. He appears as present for duty on all muster rolls from March 21, 1862 through October of 1864. Also, two receipt rolls for clothing on March 23 and June 21 of 1864. Daniel Garrett applied for a soldier's pension from North Carolina on July 4, 1910 in Washington County, NC. At the time of application, he was 71 years of age and a resident of Plymouth. He stated that he had enlisted in Company G, 17th NC Infantry Regiment in June of 1862. Physician stated he had senile debility. Approved for Class B pension,

GIBSON, B. O. O.

The first roster of the association lists B. O. O. Gibson as having been in Company A, 32nd NC Infantry Regiment. However, there is no service record of a soldier with a name close to this in Company A, 32nd NC Infantry Regiment. Records of Tyrrell County and surrounding counties show no one with a name close to this other than Burgoyne Gibson, who is also listed on the association's first roster.

GIBSON, BURGOYNE

A son of Joseph Gibson and Hannah Meekins who was born about 1843 in Tyrrell County, NC. He appears in Tyrrell County census records from 1850 through 1880. Listed in Confederate Veterans Association records as being in the Rangers during the Civil War and listed as dead before 1900. He was probably in the ranger company of Captain William H. Spencer. No muster rolls exist for this unit. The only service records extant are prisoner of war records for those members of the unit who were captured in a Federal raid at Fairfield, Hyde County.

GIBSON, WILLIAM L.

Resident of Tyrrell County, NC who enlisted in Company A, 32nd NC Infantry Regiment at age 23 at Portsmouth, Virginia on November 15, 1861. Present on muster rolls from Nov-Dec 1861, when listed as sick in quarters, to Nov-Dec 1863. Hospitalized at Episcopal Church Hospital, Williamsburg, VA from July 26, 1862 to August 22, 1862 for rubeola. Captured at Strasburg, VA on October 19, 1864, sent to Harper's Ferry, VA and then imprisoned at Point Lookout, MD on October 28, 1864. Listed on muster rolls from Sep-Oct 1864 to Jan-Feb 1865 as absent, prisoner of war. Paroled on March 28, 1865 and transferred to Boulware's Wharf, VA for exchange. William L. Gibson applied for a soldier's pension from North Carolina on June 12, 1901 in Tyrrell County, NC. At the time of application, he was 60 years of age and a resident of Columbia. He stated that he enlisted in Company A, 32nd NC Infantry Regiment on or about May 16, 1861. Wounded by a shell at Winchester, VA on October 10, 1861 causing him to be deaf in both ears. Also has right inguinal hernia caused by injury while at the front. He was recommended for a class two pension.

GODWIN, LEVIN

Resident of Tyrrell County, NC who enlisted in Company A, 32nd NC Infantry Regiment at age 40 on November 15, 1861 at Portsmouth, VA. Listed as absent, detailed cutting logs for mess rooms on Nov-Dec 1861 muster roll. Then present until discharged July 16, 1862 under

provisions of the Conscription Act and for being over thirty-five years old. Discharge states he is forty-five years old, five feet nine inches in height, of dark complexion, gray eyes and dark hair.

GRAY, WILLIAM M.

Resident of Tyrrell County, NC, where he enlisted at age 25 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Present on all existing muster rolls of Company A, 32nd Infantry Regiment from Nov-Dec 1861 through Nov-Dec 1863. Captured on May 10, 1864 at what is variously described as near Mine Run, VA or at Spotsylvania Court House, VA. Imprisoned on May 18, 1864 at Point Lookout, MD and transferred to Elmira, NY on August 3, 1864. Appears on muster rolls from Sep-Oct 1864 through Jan-Feb 1865 as absent, prisoner of war. Released at Elmira after taking the Oath of Allegiance on June 27, 1865, at which time he is listed as a resident of Plymouth, NC and described as having a florid complexion, auburn hair, blue eyes and being 5 foot 7 inches in height. William M. Gray applied for a soldier's pension from North Carolina on July 6, 1908 in Washington County, NC. At the time of application, he was 67 years of age and a resident of Creswell. He stated that he had enlisted in Company A, 32nd NC Infantry Regiment in 1861. Wounded in the right hip and this has incapacitated him from doing manual labor for the last 10 years. His widow, Nancy Gray, applied for a widow's pension from North Carolina on July 6, 1914 in Washington County, NC. At the time of application, she was 75 years of age and a resident of Creswell.

HARDISON, WILLIAM H.

Resident of Washington County, NC who enlisted at age 18 in Company A, 32nd NC Infantry Regiment at Fredericksburg, Virginia on June 1, 1863. Present on muster rolls from May-Jun 1863, when listed as a teamster, through Nov-Dec 1863. A bounty roll dated April 1, 1864 shows him home on sick furlough. Present on muster rolls from Sep-Oct 1864 through Jan-Feb 1865. Promoted to Sergeant Major and transferred to the Field and Staff of the Regiment on January 18, 1865. Paroled at Appomattox Court House, VA on April 9, 1865. W. H. Hardison applied for a soldier's pension from North Carolina on July 6, 1914 in Washington County, NC. At the time of application, he was 69 years of age and a resident of Creswell. He stated that he enlisted in Company A, 32nd NC Infantry Regiment on or about November 1862. No wounds cited. Suffers from mitral stenosis, chronic bronchitis and gradually increasing inability to work as a physician. Disallowed due to owning too much property. W. H. Hardison applied again on July 4, 1921 in Washington County, NC. He was 76 years of age and a resident of Creswell at the time of application. He stated that he enlisted in Company A, 32nd NC Infantry Regiment on or about May 1862. No wounds cited. Approved for a class four pension.

HARRISON, N(EWSOME) H(ENRY)

Not listed as a member of the Association, but mentioned as one of the veterans living in Tyrrell and Washington Counties for whom the Association received Crosses of Honor from the Pamlico Chapter of the United Daughters of the Confederacy in 1912. Enlisted on June 1, 1864 in Battery H, 1st NC Artillery Regiment (Company H, 10th Regiment NC Troops) at Plymouth, NC for the war. Present on the Jul-Aug 1864 and Nov-Dec 1864 muster rolls. Absent, scout for Dept. NC on Jan-Feb 1865 muster roll. N. H. Harrison applied for a soldier's pension from North Carolina on July 6, 1914 in Washington County, NC. At the time of application, he was 68 years of age and a resident of Pinetown. He stated that he enlisted in Company H, 10th Regiment NC Troops on May 1, 1864. Suffering from gradually increasing inability to work and senile debility. Disallowed because of the value of his property. N. H. Harrison applied again for a soldier's pension from North Carolina on July 2, 1921 in Washington County, NC. At the time of application, he was 76 years of age and a resident of Pinetown. He stated that he enlisted in Company H, 10th Regiment NC Troops on May 30, 1864. Approved for a class four pension.

HASSELL, J. S./CALVIN S.

Both are listed only once and on the same roster as having served in Company G, 1st NC Infantry Regiment. The only records that exist for this unit are for Calvin S. Hassell, who enlisted in Company G, 1st NC Infantry Regiment at Columbia, NC on January 28, 1862 for the war. Admitted to Chimborazo Hospital No. 4, Richmond, VA on September 8, 1862 with measles, from which he was furloughed from October 24 to November 14, 1862. Appears on a register of Chimborazo Hospital No. 3, Richmond, VA as having been admitted October 23, 1862 with diarhhea and deserted from hospital October 28, 1862. Reported as absent without leave on all muster rolls commencing with Nov-Dec 1862.

HASSELL, LEONARD L.

Enlisted in Tyrrell County, NC, and elected 1st Lieutenant on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present on muster rolls until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Present on all subsequent muster rolls of Company A, 32nd Infantry Regiment until May-Jun 1862 when his status is not stated and Jul-Aug 1862, when shown as absent on sick leave. He tendered his resignation on July 23, 1862. E. C. Brabble, the commander of the regiment, approved his request to resign saying that he was fomenting dissatisfaction within his company and it would be of benefit to the service for him to leave it. The resignation became final on September 13, 1862.

HASSELL, W(ILLIAM) H.

Enlisted at age 21 on May 3, 1861 at Plymouth, NC in Company H, 17th NC Infantry Regiment (First Organization). Mustered in on June 20, 1861 at Beacon Island. Mustered out of the company at Williamston, NC on March 20, 1862. Enlisted at age 21 in Battery B (Edenton Bell Battery), 3rd Battalion NC Light Artillery on January 27, 1862 at Edenton, NC. Mustered in at Camp Mangum, NC on March 27, 1862. Described as a farmer born in Washington County, NC who was 5 feet, 9 inches in height. Listed as absent on furlough and special service at the time. Present on all existing muster rolls until May-Jun 1863 when absent sick at headquarters of the battalion. Promoted to corporal in January or February of 1863. On detached service at Kenansville on the Jul-Aug 1863 muster roll. Present on subsequent muster rolls through Nov-Dec 1864. Listed as present on a muster roll of officers and men paroled in accordance with a Military Convention entered into on the 26th day of April, 1865, between General Joseph E. Johnston, Commanding Confederate Army, and Major General W. T. Sherman, Commanding United States Army in North Carolina. Roll is dated April 28, 1865 at Greensboro, NC and parole is effective May 1, 1865. W. H. Hassell's widow, Millie Ann Hassell, applied for a widow's

pension from North Carolina on July 6, 1908 in Washington County, NC. At the time of application, she was 72 years of age and a resident of Creswell. She stated that her husband enlisted in William Badham's Artillery (3rd Batallion, NC Light Artillery) in 1861. He died March 30, 1898. Millie Ann Hassell was approved for a class four pension.

HOOKER, DANIEL S.

Resident of Tyrrell County, NC, where he enlisted at age 20 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present on muster rolls until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Present on the muster rolls of Company A, 32nd Infantry Regiment until severely wounded in the shoulder and thigh and captured at Gettysburg, PA between July 1 and July 5, 1863. Hospitalized at Gettysburg until September 14, 1863, when transferred to a hospital in Baltimore, MD. Paroled there on September 25, 1863 and sent to City Point, VA for exchange, arriving on September 27, 1863. Admitted to General Hospital No. 9, Richmond, VA on September 28, 1863 and sent to Winder Hospital No. 4, Richmond, VA on September 29, 1863. He subsequently appears as a patient on the muster roll of Wayside Hospital No. 4, Goldsboro, NC for Nov-Dec 1863 and Jan-Feb 1864. Company muster Rolls list him as wounded and taken prisoner for Jul-Aug 1863, wounded and in hospital in Goldsboro, NC for Sep-Oct 1863 and as a wounded and paroled prisoner for Nov-Dec 1863. Transferred to C. S. Navy April 15, 1864.

HOPKINS, J(OSEPH) W.

Enlisted April 2, 1862 at age 38 at Hamilton, NC in Company H, 17th NC Infantry Regiment (Second Organization). The company was mustered in at Camp Johnson on June 17, 1862, but he had already been discharged on May 29, 1862. Described as a farmer born in Washington County, NC and 5 feet, 10 inches in height. A receipt roll indicates he was paid for service in the 17th NC Infantry Regiment (First Organization) from November 2, 1861 to March 1, 1862. Joseph Hopkins applied for a soldier's pension from North Carolina on November 2, 1901 in Tyrrell County, NC. At the time of application, he was 76 years of age and a resident of Columbia, NC. He stated that he enlisted in Company H, 17th NC Infantry Regiment on or about November 1, 1861. Wounded in both legs at Newbern, NC on March 16, 1862. Contracted heart, lung and bowel diseases. Approved for class four pension.

JARVIS, WM. H.

This name only appears on one roster of the Association. The unit designation appears to be Battery A, 3rd Battalion NC Light Artillery, but there is no record of a Jarvis serving in this battalion. The name William H. Jarvis also appears in no census records of the area. There was a William M. Jarvis who was enlisted by H. C. Whitehurst on February 16, 1862 in what later became Battery I, 3rd Artillery Regiment (40th State Troops) at Washington (Beaufort County) for the war. Muster roll for January 23 – July 1, 1862 states he was absent, taken in action New Bern, NC. Muster roll for Jul-Aug 1862 also states absent, taken in action New Bern on March 14, 1862. Roll of honor indicates he was 24 years of age at enlistment. No further record. To further complicate matters there was a William M. Jarvis, age 22, who enlisted at Washington (Beaufort County) in Company G, 2nd NC Cavalry Regiment on July 18, 1861 for the war. He is shown as present on all six muster rolls for 1862. The Jan-Feb 1863 muster roll says he brought his own horse into service on January 1 and is absent on detail to procure fresh horse. Absent on detail again on Mar-Apr 1863 muster roll and then present from May-Jun through Sep-Oct 1863 muster rolls. No muster roll until April through October 1864 when present. He had been promoted from private to 5th sergeant by this time. On April 1, 1865 he was captured at Five Forks and was imprisoned at Point Lookout, MD until June 19, 1865 when he took the Oath of Allegiance. At that time, he was described as having a fair complexion, light brown hair, blue eyes, 5 feet 10 inches in height and a resident of Tyrrell County.

JONES, THOMAS L.

Resident of Tyrrell County, NC, where he enlisted at age 22 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present on muster rolls until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Promoted to Sergeant May 11, 1862. Present on the muster rolls of Company A, 32nd Infantry Regiment through Nov-Dec 1863. Captured on May 10, 1864 at what is variously described as near Mine Run, VA or Spotsylvania Court House, VA. Imprisoned on May 18, 1864 at Point Lookout, MD and transferred to Elmira, NY on August 3, 1864. Paroled there on March 10, 1865 and transferred to Boulware's Wharf, VA for exchange. Listed on muster rolls from Sep-Oct 1864 through Jan-Feb 1865 as a prisoner of war.

JONES, W(ILLIAM) H.

Enlisted at age 20 at Edenton, NC on January 21, 1862 in Battery B (Edenton Bell Battery), 3rd Battalion NC Light Artillery. Mustered in on March 27, 1862 at Camp Mangum, NC. Described as a merchant 5 feet, 7 inches in height. Present until the May-Jun and Jul-Aug 1863 muster rolls when listed as absent on detached service at Kenansville, NC. Subsequently present until the May-Jun 1864 roll when absent on special furlough for 48 hours commencing June 29, 1864. Then present on muster rolls through Nov-Dec 1864. Present on a muster roll of officers and men paroled in accordance with a Military Convention entered into on the 26th day of April, 1865, between General Joseph E. Johnston, Commanding Confederate Army, and Major General W. T. Sherman, Commanding United States Army in North Carolina. Roll is dated April 28, 1865 at Greensboro, NC and parole is effective May 1, 1865.

KEMP, WASHINGTON C.

Enlisted in Company H, 17th NC Infantry Regiment (Second Organization) on October 11, 1863 at Fosters Mill. Present on muster rolls from Mar-Apr 1864 through Sep-Oct 1864, except listed as absent sick at infirmary August 25, 1864. No muster rolls subsequent to that. Appears on a prisoner of war list as having been captured at Bentonville, NC on March 14, 1865. Imprisoned at Point Lookout, MD on March 30, 1865 and released on June 28, 1865 after taking the Oath of Allegiance, at which time he is listed as a resident of Washington County and described as having a fair complexion, brown hair, gray eyes and being 5 foot 5 ¼ inches in height. Washington C. Kemp applied for a soldier's pension from North Carolina on July 1, 1901 in Tyrrell County, NC. At the time of application, he was 58 years of age and a resident of Bay. He stated that he enlisted in Company H, 17th NC Infantry Regiment on or about October 11, 1863. Wounded by a shell burst at Petersburg, VA on July 31, 1864 which rendered him unconscious for a long time and resulted in pneumonia which has never been cured. Recommended for class three pension.

KEMP, WILLIAM W.

Born in Currituck County, NC and enlisted at age 20 at Columbia, NC in Battery B (Edenton Bell Battery), 3rd Battalion NC Light Artillery on February 4, 1862. Mustered in on March 27, 1862 at Camp Mangum, NC. Described as a seaman 5 feet, 8 inches in height. Present on all battery muster rolls through Nov-Dec 1864. Present on a muster roll of officers and men paroled in accordance with a Military Convention entered into on the 26th day of April, 1865, between General Joseph E. Johnston, Commanding Confederate Army, and Major General W. T. Sherman, Commanding United States Army in North Carolina. Roll is dated April 28, 1865 at Greensboro, NC and parole is effective May 1, 1865. W. W. Kemp applied for a soldier's pension from North Carolina on July 13, 1908 in Tyrrell County, NC. At the time of application, he was 67 years of age and a resident of Gum Neck. He stated that he enlisted in Company A, 3rd Battalion, NC State Troops on or about September 30, 1861. No wounds received but unable to perform labor due to old age and chronic diarrhea.

KNIGHT, THOMAS W.

Resident of Tyrrell County, NC, where he enlisted at age 42 and was mustered in as a sergeant on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present or accounted for until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Sick at the battalion hospital on the Sep-Oct 1861 muster roll. A regimental return of December 1861 shows he went on sick furlough to Columbia, NC on November 13, 1861 but was little improved. On muster roll of Jan-Feb 1862 he was on detached service in Portsmouth, VA to take care of the baggage belonging to the battalion. Sick in Camp Benjamin near Portsmouth, VA on the Mar-Apr 1862 muster roll. Discharged under provisions of the Conscription Act on May 11, 1862. Mary R. Knight, widow of Thomas W. Knight, applied for a widow's pension from North Carolina on June 8, 1901 in Tyrrell County, NC. At the time of application, she was 58 years of age and a resident of Columbia. She stated that her husband, Thomas W. Knight, had enlisted in Company A, 32nd NC Infantry Regiment on or about May 16, 1861.

KNOWLES, WILLIAM. F.

Enlisted at age 27 at Plymouth, NC in Company H, 17th NC Infantry Regiment (First Organization) and mustered into service on June 20, 1861 at Beacon Island as a private. Company mustered out on March 20, 1862 at Williamston, NC. Listed as absent, serving in another company at that time. Enlisted in Company H, 17th NC Infantry Regiment (Second Organization) on April 2, 1862 at Hamilton, NC at the rank of sergeant. Mustered in at Camp Johnson on June 17, 1862. Described as a farmer 25 years of age born in Washington County, NC who was 5 feet, 8 ½ inches tall. Present on all muster rolls from Apr-Jun 1862 through Jul-Aug 1863 when present but sick. Present on subsequent muster rolls through Sep-Oct 1864. Captured at Plymouth, NC on March 8, 1865 and imprisoned at Point Lookout, MD on March 30, 1865. Released June 28, 1865 after taking the Oath of Allegiance, at which time he was described as being a resident of Washington County, NC and having a light complexion, brown hair, gray eyes and being 5 feet,

7 ½ inches in height. William F. Knowles applied for a soldier's pension from North Carolina on July 5, 1904 in Tyrrell County, NC. At the time of application, he was 67 years of age and a resident of Bay. He stated that he had enlisted in Company H, 17th NC Infantry Regiment on or about April 21, 1862. No wounds are cited in the application but he is disabled due to Bright's disease and failing eyesight. He was approved for a class four pension.

LITCHFIELD, JAMES

Resident of Tyrrell County, NC who enlisted at age 30 in Company A, 32nd NC Infantry Regiment in Portsmouth, Virginia on November 15, 1861. Admitted to General Hospital, Petersburg on September 2, 1862 with rubeola and furloughed 30 days on October 31, 1862. Regimental returns of November and December 1862 and muster rolls of Nov-Dec 1862 and Jan-Feb 1863 indicate he had not returned. Muster roll of Mar-Apr 1863 says he had started back to his regiment at some time but was taken prisoner at Plymouth, NC, paroled and immediately returned to his unit. Present on muster rolls from that point through December 1863. Captured on September 19, 1864 at Winchester, Virginia and imprisoned at Point Lookout, MD on September 26, 1864. Paroled on or about March 15, 1865 for exchange and sent to Boulware's Wharf, Virginia. James Litchfield applied for a soldier's pension from North Carolina on July 4, 1901 in Tyrrell County. He stated that he enlisted in Company A, 32nd NC Infantry Regiment on or about September 10, 1861 and is now age 68 and a resident of Columbia. He was wounded in the right thumb at an unspecified date and wounded in the left breast at Winchester, VA on September 19, 1864. A doctor certified that he had a bad scar on his right foot and right hand, the results of wounds. Also, a gunshot wound on the left breast near the armpit. On the rolls as a class four pensioner and it was recommended that he be made a class three pensioner. The earlier pension application apparently no longer exists.

MAJETTE, MARK

Census records show that Mark Majette was an attorney in Columbia, NC who was born in 1865 in Hertford County, NC, so he was too young to have served in the Civil War. There is no record of his father, William J. Majette, having military service in the Civil War either.

McCABE, J(AMES) F.

Appears on a muster roll of Lee's Company, Alabama Light Artillery for Jul-Aug 1864 as having enlisted in July 1864 and being absent with a section of artillery at Little Bethel, NC. The only other record is a receipt roll for clothing in the 3rd quarter of 1864. The original name of this unit was the Montgomery True Blues, a company in the 3d Alabama Infantry Regiment. This regiment was sent to Virginia in 1861 but saw no action for a year. During this time, it was reorganized and the Montgomery True Blues became an independent battery operating in eastern North Carolina, first at Kinston, NC, then at Plymouth, NC and finally at Fort Branch near Hamilton, NC.

McCABE, HAYWOOD

Born in Washington County, NC and enlisted at age 21 at Hamilton, NC on April 2, 1862 in Company H, 17th NC Infantry Regiment (Second Organization). Mustered into service at Camp Johnson on June 17, 1862. Described as a farmer who was 5 feet, 8 ½ inches tall. Listed as

present at Hamilton on muster rolls until Nov-Dec 1863 when listed as absent on detached service. Rejoined from detached service on January 19, 1864. Present on muster rolls at Hamilton until listed as absent sick at infirmary on August 15, 1864. The Sep-Oct 1864 muster roll shows him absent, furloughed from Winder Hospital at Tarboro, NC for 30 days on September 19, 1864 and then absent without leave. No muster rolls or other records subsequent to that. H. B. McCabe applied for a soldier's pension from North Carolina on July 1, 1901 in Washington County, NC. He was 63 years of age and a resident of Scuppernong at the time of application. He stated that he enlisted in Company H, 17th NC Infantry Regiment on or about October 5, 1861. He was not wounded and has an inguinal hernia on the right side and general debility of old age. Approved for class four pension.

MERRITT, GEORGE

Resident of Tyrrell County, NC, where he enlisted at age 30 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Present on the muster rolls of Company A, 32nd NC Infantry from Sep-Oct 1861 through Nov-Dec 1863. Listed as home on furlough on the Sep-Oct 1861 muster roll. Muster rolls for Jan-Feb 1864 through Jul-Aug 1864 do not exist, but he was admitted to General Hospital No. 9, Richmond, VA on 13 May 1864 for unspecified reasons. From there he was sent to Winder Hospital, Richmond, VA. In all probability, he was wounded at the battle of Spotsylvania Courthouse. Present or accounted for on muster rolls from Sep-Oct 1864 through Jan-Feb 1865. Listed as sick in camp on the Nov-Dec 1864 muster roll. Captured at Harpers Farm, VA on April 6, 1865. Imprisoned at Point Lookout, MD on April 15, 1865 and released on June 29, 1865 after taking the Oath of Allegiance, at which time he is listed as a resident of Tyrrell County and described as having a dark complexion, dark brown hair, hazel eyes and being 5 foot 7 ¼ inches in height.

MOORE, S(TEPHEN) E(DWIN)

Enlisted on May 1, 1861 at Williamston, NC in Company F, 17th NC Infantry Regiment (First Organization). Mustered into service at Hatteras Island, NC on July 26, 1861. Born in Martin County, NC. Appears on a record of prisoners of war at Fort Warren, MA as having been captured at Hatteras, NC on August 29, 1862, received at Fort Warren on November 1, 1862, paroled at Fort Warren on January 31, 1862 and released for exchange at Fort Monroe, VA on February 3, 1862. Mustered out at Williamston, NC on March 20, 1862. Enlisted on July 8, 1862 in Martin County, NC in Company G, 3rd NC Cavalry Regiment. Present on muster rolls of Sep-Oct and Nov-Dec 1862. Sometime after that the company was redesignated as Company K, 3rd NC Cavalry Regiment. On the next existing muster roll in Nov-Dec 1863 he is listed as absent without leave since December 24, 1863. The next muster roll says he returned to the company on January 27, 1864 and now has a horse. Present on all subsequent muster rolls through Sep-Oct 1864, after which there is no further record except receipts for clothing in November and December 1864. Stephen E. Moore applied for a soldier's pension from North Carolina on July 1, 1901 in Tyrrell County, NC. He stated that he enlisted on May 1, 1862 in Company K, 3rd NC Cavalry Regiment and was wounded at Hatteras on August 28, 1861. Doctor's statement cites a shell wound to the left wrist rendering the arm of little use for labor. He also suffers from a disease of both lungs and bladder. On the rolls as a class four pensioner and it is recommended that he be made a class three pensioner. The earlier pension application apparently no longer exists. His widow, M. F. Moore, age 66 and a resident of Plymouth, NC applied for a widow's pension on July 3, 1916.

NORMAN, JOHN J. (Listed as John I. Norman in records of the Confederate Veterans Association and in pension records)

Born in Tyrrell County and enlisted at age 37 in Company H, 17th NC Infantry Regiment (Second Organization) at Hamilton, NC on April 2, 1862. Discharged on May 29, 1862. Described as a farmer 6 feet in height. A pay receipt roll indicates that he was paid for service in the 17th NC Infantry Regiment (First Organization) from November 2, 1861 to March 1, 1862. There are no other records relating to this service. John I. Norman applied for a soldier's pension from North Carolina on June 8, 1901 in Tyrrell County, NC. At the time of application, he was 68 years of age and a resident of Gum Neck. He stated that he enlisted in Company H, 17th NC Infantry Regiment on or about April 21, 1862. Wounded in the right side and left groin in the fight at Newbern, NC in 1862. The wound in the left groin resulted in a risen boil or abcess that, along with the afflictions of old age prevent him from manual labor.

NORMAN, NEHEMIAH

Enlisted at age 25 on April 2, 1862 at Hamilton, NC in Company H, 17th NC Infantry Regiment (Second Organization). Mustered in at the rank of corporal at Camp Johnson on June 17, 1862. Described as a farmer, born in Washington County, NC and 5 feet, 6 inches in height. Present on company muster rolls until May-Jun 1863 when reported as sick in hospital in Hamilton, NC. Subsequently present until the muster roll of May-Aug 1864 when reported absent sick at the infirmary since August 18, 1864. Sent to Camp Winder Hospital, Richmond, VA on September 26, 1864, from which he was returned to duty on November 5, 1864. Captured near Kinston, NC on March 10, 1865 and imprisoned at Point Lookout, MD on March 16, 1865. Released on June 29, 1865 after taking the Oath of Allegiance, at which time he was described as being a resident of Tyrrell County, of light complexion, light brown hair, hazel eyes and being 5 feet, 6 inches in height. Nehemiah Norman applied for a soldier's pension from North Carolina on July 7, 1902 in Washington County, NC. At the time of application, he was 64 years of age and a resident of Creswell. He stated that he enlisted in Company H, 17th NC Infantry Regiment on or about November 13, 1861. Wounded in the corner of the left eye at Cold Harbor, VA and received a slight wound in the stomach at Kinston, NC. Now almost totally blind. Doctor statement says disability is more due to senility than anything else. Approved for a class four pension. His widow, Ellen E. Norman, applied for a widow's pension from North Carolina on July 3, 1911 in Washington County, NC. At the time of application, she was 66 years of age and a resident of Creswell. Another application was filed on April 25, 1935 in Washington County, NC to advance Ellen E. Norman from a Class B pensioner to a Class A pensioner due to total disability.

OWENS, WILLIAM. M(ATHIAS)

Died in 1883 before the Confederate Veterans Association was formed, but two sons, Herbert A. Owens and William F. Owens became members when the sons of Confederate veterans became eligible. Enlisted at age 18 on July 18, 1861 at Washington, NC in Company G, 2nd NC

Cavalry Regiment. Promoted to corporal on March 15, 1862. Promoted to sergeant on July 15, 1862. Promoted to 3rd lieutenant on September 15, 1862. Promoted to 2nd lieutenant on July 14, 1863. Promoted to captain on September 13, 1864. Status either present or not stated on existing muster rolls from Jan-Feb 1862 through Sep-Oct 1863. Status not stated on muster rolls covering April through September of 1864. Service records contain many requisitions for supplies from 1862 through 1864. One shows a loss of five horses by his company in an engagement near Hagerstown, MD on July 10, 1863.

PATRICK, S(AMUEL) C.

Enlisted in October of 1863 in Company A, 66th NC Infantry at Columbia, NC. A member of Captain William H. Spencer's partisan rangers and captured near Fairfield, NC on February 20, 1864. Imprisoned at Point Lookout, MD and paroled for exchange on January 17, 1865. Appears on the muster roll of a detachment of paroled and exchanged prisoners at Camp Lee dated January 26, 1865.

PHELPS, BAILEY

Enlisted at Camp Holmes, NC on September 9, 1864 in Company G, 18th NC Infantry Regiment. Present on Sep-Oct 1864 through Jan-Feb 1865 muster rolls. Admitted to Jackson Hospital, Richmond, VA on March 28, 1865 with rheumatismus. Appears on a roll of prisoners of war captured at Richmond, VA hospitals on April 3, 1865. Paroled at Richmond, VA on May 29, 1865 and appears on a register of the Provost Marshal, District of Henrico on August 17, 1865 as a farmer, age 27, from North Carolina. Bailey Phelps applied for a soldier's pension from North Carolina on July 1, 1901 in Washington County, NC. At the time of application, he was 68 years of age and a resident of Creswell. He stated that he enlisted in Company G on or about 1863. No wounds cited. He is idiotic and can't care for himself. Has no relatives able to care for him. Approved for class four pension. Applied for admission to the North Carolina Soldier's Home, Raleigh, NC on January 6, 1906 in Washington County, NC. At the time of application, he is described as unmarried, age 75, of fair complexion, 5 feet, 9 inches in height and having no relatives. Enlisted in Company G (68th Regiment?) and discharged as cripple in September 1864. Enlisted in the 18th Regiment in New Hanover County, NC on September 9, 1864 and was discharged at the close of the war. Admitted to the Soldier's Home on February 28, 1906.

PHELPS, D(ANIEL) S.

Enlisted at Camp Holmes near Raleigh, NC on September 7, 1864. Absent, sick in hospital on the Sep-Oct and Nov-Dec 1864 muster roll. Present on the Jan-Feb 1865 muster roll. Deserted to the enemy on or about March 30, 1865. Confined at Washington, DC on or about April 4, 1865. Released on an unspecified date after taking the Oath of Allegiance and transportation furnished to Plymouth, NC.

PHELPS, J(AMES) D(ALLAS)

There is a James Phelps who enlisted at age 24 in 1862 and a James Phelps Jr. who enlisted at age 16 in 1863 in the records of Company H, 17th NC Infantry Regiment (Second Organization). The 1900 Tyrrell County census has a James D. Phelps born in 1847 who would have been age 16 in 1863, so it is presumed that the younger James Phelps Jr. in service records is the member

of the Confederate Veterans Association. Muster rolls of Company H, 17th NC Infantry Regiment (Second Organization) indicate he enlisted at Fosters Mill, NC or Williamston, NC on October 11, 1863 at age 16. He was subsequently present on all muster rolls until Apr 30-Aug 31 1864 where he is shown as being absent, sick in the infirmary since August 20, 1864. He next appears on a roll of prisoners captured at Ft. Fisher on February 11, 1865. From there he was sent to Point Lookout, MD via Ft. Anderson and imprisoned at Point Lookout on February 28, 1865. He was released at Point Lookout on June 16, 1865 after taking the Oath of Allegiance, at which time he is listed as a resident of Tyrrell County and described as having a dark complexion, brown hair, blue eyes and being 5 foot 5 ½ inches in height. James Dallas Phelps applied for a soldier's pension from North Carolina on July 5, 1909 in Tyrrell County, NC. At the time of application, he was 63 years of age and a resident of Creswell. He stated that he enlisted in Company H in October 1862. No wounds cited. Has a right side rupture. Approved for class four pension. His wife, Mary Matilda, applied for a widow's pension on September 12, 1927 in Tyrrell County, NC. It states that her late husband was not a deserter, they were married on January 15, 1898 and he died on July 4th or 5th, 1927. This application was disallowed. She applied again on July 1, 1929 in Tyrrell County, NC. Information the same except for husband's death being July 30, 1927 and marriage on January 16, 1898. A class B pension was approved on August 22, 1931.

ROADS/RHODES, JOHN W.

Resided in Tyrrell County and enlisted at age 22 at Portsmouth, VA on November 15, 1861 in Company A, 32nd NC Infantry Regiment. Present sick in quarters on Nov-Dec 1861 muster roll. Present on all subsequent muster rolls through Nov-Dec 1864 except listed absent in hospital in Petersburg on Jul-Aug 1862 muster roll. Captured at a location variously described as near Mine Run, VA or Spotsylvania Court House, VA on May 10, 1864. Confined at Point Lookout, MD on May 18, 1864. Transferred to Elmira, NY where he arrived on August 6, 1864. On a roll dated November 30, 1864, of prisoners of war at Elmira desiring to take the Oath of Allegiance. He took the Oath of Allegiance at Elmira on May 19, 1865, but was too sick to travel. Released at Elmira on or about July 3, 1865, at which time he is listed as a resident of Tyrrell County and described as having a sallow complexion, dark hair, blue eyes and being 5 foot 10 inches in height. John W. Rhodes applied for a soldier's pension from North Carolina on July 5, 1909 in Tyrrell County, NC. At the time of application, he was 68 years of age and a resident of Columbia. He stated that he had enlisted in Company A, 32nd NC Infantry Regiment on September 15, 1861. No wounds are mentioned but he is suffering from a right inguinal hernia held in place by a truss and from an injured back. He was approved for a class four pension.

SANDLIN/SANDERLIN, DANIEL S.

Resident of Tyrrell County, NC, who enlisted at Columbia, NC at age 25 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Promoted from private to sergeant on October 28, 1861. Promoted to 1st sergeant on September 1, 1862. Reduced to ranks at his own request on December 15, 1862. On duty at Chesterfield Court House on a regimental return of December 1862. Present on all company muster rolls from Sep-Oct 1861 through Nov-Dec 1863. Detailed as a drummer on the Nov-Dec 1864 muster roll and a bounty roll of April 1, 1864. Captured at a location variously described as near Mine Run, VA or Spotsylvania Court House, VA on May 10, 1864. Confined at Point Lookout, MD on May 18, 1864. Transferred to Elmira, NY where he arrived on August 6, 1864. Released at Elmira on June 27, 1865 after taking the Oath of Allegiance, at which time he is listed as a resident of Plymouth, NC and described as having a dark complexion, dark hair, gray eyes and being 5 foot 5 inches in height. Daniel S. Sanderlin applied for a soldier's pension from North Carolina on July 1, 1901 in Dare County, NC. At the time of application, he was 62 years of age and a resident of East Lake. He stated that he enlisted in Company A, 32nd NC Infantry Regiment on May 16, 1861. Wounded at Gettysburg, PA on July 2, 1863. Suffered injuries from exposure and rough usage that have affected his health since the war. Approved for class four pension.

SAWYER, JOHN A.

Born in Tyrrell County and enlisted at age 23 at Columbia, NC in Battery B (Edenton Bell Battery), 3rd Battalion NC Light Artillery on February 4, 1862. Mustered in on March 27, 1862 at Camp Mangum, NC. Described as a farmer 5 feet, 8 inches in height. Absent in hospital at Raleigh, NC through muster roll of May-Jun 1862. Absent without leave on muster rolls of Jul-Aug 1862 and Sep-Oct 1862. Listed as deserter on muster roll of Jan-Feb 1863. Enlisted again in Tyrrell County on October 1, 1863. Present on muster rolls of Sep-Oct 1863 and Nov 1-Mar 1 1864. Absent on detail in Wilmington, NC from April 8, 1864 through the muster roll of Nov-Dec 1864. Present on a muster roll of officers and men paroled in accordance with a Military Convention entered into on the 26th day of April, 1865, between General Joseph E. Johnston, Commanding Confederate Army, and Major General W. T. Sherman, Commanding United States Army in North Carolina. Roll is dated April 28, 1865 at Greensboro, NC and parole is effective May 1, 1865. Incomplete application for a soldier's pension from North Carolina for John A. Sawyer dated July 3, 1911 in Tyrrell County, NC. W. W. Kemp states that he served with him in Company B, 3rd NC Battalion (Edenton Bell Battery). Doctor states he is totally disabled, both mentally and physically. Suffering from Bright's disease and his sight is much impaired. Not able to leave home and go before the pension board. Approved for class four pension. Affidavit by D. C. Sawyer, son of John A. Sawyer, on July 3, 1911 that his father is 67 years of age, a resident of Gum Neck, NC and is the identical John A. Sawyer who enlisted on or about 1863 in Company B, 3rd Battalion NC State Troops (Edenton Bell Battery) and served to the end of the war.

SAWYER, SAMUEL L.

Resident of Tyrrell County, NC, where he enlisted at Columbia, NC at age 27 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Present until Nov-Dec 1861 when sick in quarters. Subsequently present until Sep-Oct 1864 when absent sick in hospital. Appears on a muster roll of sick soldiers at the General Hospital, Camp Winder, Richmond, VA on April 30, 1864 and again on a register of General Hospital No. 9, Richmond, VA where he was admitted on June 1, 1864 and sent to Camp Winder on June 2, 1864. Present in arrest on the muster roll of Nov-Dec 1864 and present on the Jan-Feb 1865 muster roll. Wounded in the right arm near Petersburg, VA on April 2, 1865 and assumed to be captured on an unspecified date but there is no record of it. Admitted to Point of Rocks Hospital, VA on May 8, 1865 and sent to the U. S. A. General Hospital, Fort Monroe, VA on May 17, 1865 where he was admitted with a gunshot fracture of the right arm and the lower third of his right arm was amputated. Discharged from the hospital on taking the Oath of Allegiance on July 9, 1865. Samuel L. Sawyer applied for a soldier's pension from North Carolina on June 12, 1885 from Washington County, NC. At the time of application, he was 48 years of age and a resident of Creswell. He stated that he enlisted in Company A, 32nd NC Infantry Regiment on or about May 25, 1861. Wounded at Petersburg, VA on April 2, 1865, when his right arm was shot off above the elbow. Previously wounded in the chin and throat at Winchester and in the thigh at Mechanicsville. S. L. Sawyer applied to have his soldier's pension from North Carolina made a class two pension under the 1901 Law on June 19, 1901 in Tyrrell County, NC. Stated that he enlisted in Company A, 32nd NC Infantry Regiment on May 16, 1861. He was age 65 and residing in Gum Neck at the time of application and had been wounded above the elbow of his right arm which had to be amputated. This happened at Petersburg, VA on April 2, 1865.

SAWYER, W(ASHINGTON) J.

Enlisted February 10, 1862 at age 19 in Company I, 40th Regiment (North Carolina Troops), also known as the 3rd NC Artillery. The place of enlistment is shown as Washington, NC in early muster rolls and Tyrrell County, NC in later muster rolls. Present on all muster rolls until Sep-Oct 1863 when shown as detailed at Zeke's Island. Appears on a roll of soldiers on extra duty at Fort Fisher, NC during the month of March 1863 where he was a boatman, rowing the garrison boat. Subsequently present until Jan-Feb and Mar-Apr 1864 when detailed to the Quartermaster Department at Fort Fisher. Then present until Sep-Oct 1864 when absent on furlough for 18 days commencing October 16, 1864. No further record. Washington I. Sawyer applied for a soldier's pension from North Carolina on July 25, 1912, in Pasquotank County, NC. At the time of application, he was 68 years of age and a resident of Elizabeth City. He stated that he enlisted in Company I, 40th Infantry Regiment on or about February 10, 1862. No wounds claimed but doctor's examination found scar one and a half inches long in scalp on the left side of the head. General debility much exceeding that to be expected in a man of his age.

SEXTON, EDMUND

Enlisted at age 22 in Company G, 2nd NC Cavalry Regiment on August 16, 1861 at Camp Clark. Present on muster rolls from Jan-Feb 1862 to Nov-Dec 1862, when listed as absent in hospital at Richmond. Listed present on muster rolls from Jan-Feb 1863 to Jul-Aug 1863 and Sep-Oct 1863 when listed as absent on detail. Absent, prisoner of war, on muster rolls from April through September 1864. On roll of prisoners at Point Lookout, MD as having been captured September 7, 1863 in Washington County, NC and released after taking the oath of allegiance on December 26, 1864. Edmond Sexton applied for a soldier's pension from North Carolina on June 22, 1901 in Tyrrell County, NC. At the time of application, he was 62 years of age and a resident of Columbia. He stated that he enlisted in Company G, 19th Regiment, NC State Troops (designation prior to being mustered into service of the Confederate States of America as Company G, 2nd NC Cavalry Regiment) on August 16, 1861. Lost his left eye from a piece of shell at Gettysburg, PA on July 3, 1863 and suffers from rheumatism caused by exposure while imprisoned at Point Lookout, MD. Approved for a class four pension.

SEXTON, SAMUEL

Although not mentioned in the minutes of the Confederate Veterans Association himself, his widow, Sarah F. Sexton, is mentioned in several places, so his service record is included here. Enlisted on January 28, 1862 at Columbia, NC in Company G, 1st NC Infantry Regiment. Listed as present but sick in camp on Mar-Apr 1862 muster roll. The Jul-Oct 1862 muster roll states that he was killed at Mechanicsville on June 26, 1862. It also says he enlisted at Plymouth, NC instead of Columbia, NC, which is more likely. Roll of honor says killed at Ellyson's Mills, which is a more specific location and where his regiment suffered over 50% casualties. Sarah F. Sexton, widow of Samuel Sexton, applied for a widow's pension from North Carolina on June 8, 1885 in Tyrrell County, NC. At the time of application, she was 45 years of age and a resident of Columbia, NC. She stated that Samuel Sexton enlisted in Company G, 1st NC Infantry Regiment on or about February 1862. He was killed in Virginia on June 6, 1862. Sarah F. Sexton, widow of Samuel Sexton, applied for an increase in her widow's pension from North Carolina on June 29, 1901 in Tyrrell County, NC. At the time of application, she was 61 years of age and a resident of Columbia, NC. She again stated that Samuel Sexton enlisted in Company G, 1st NC Infantry Regiment on or about February 1862 and that he was killed in battle near Richmond, VA during the Seven Days Battle in 1862.

SHALLINGTON, WILLIAM. E.

Enlisted at age 21 on May 10, 1861 in Washington, Beaufort County, NC in Company I, 3rd NC Infantry Regiment. Appears on company muster-in roll dated August 31, 1861 near Aquia Creek, VA as a corporal 21 years of age. Present on muster rolls of Sep-Oct and Nov-Dec 1861. Absent on leave on Jan-Feb 1862 muster roll. Still absent on furlough on Mar-Apr 1862 muster roll but taken sick at home February 20, 1862. Absent sick in hospital in Richmond, VA on May 1-Jul 14 1862 muster roll. Rank reduced to private and absent without leave P. O. Bath, Beaufort County, NC on Jul 14-Nov 1 1862 muster roll. Reported absent without leave since December 21, 1862 on muster rolls of Nov-Dec 1862 and Jan-Feb 1863. Promoted to first lieutenant in Spencer's Company to rank from February 7, 1863 on Feb 28-May 13 1863 muster roll of Company I, 3rd NC Infantry Regiment. He became first lieutenant of the independent partisan ranger company of Captain William H. Spencer which operated behind enemy lines and was based in Hyde County, NC. About one third of the men in this unit were captured in a raid by Federal troops near Fairfield, NC on February 20, 1864. The balance of the men not captured reported to Colonel George Wortham's command at Plymouth, NC on September 4, 1864, but no record can be found of their service there. The only existing records of men in Capt. Spencer's Rangers are Federal prisoner of war records. Since William E. Shallington does not appear in these records, it is assumed he escaped or was not at Fairfield at the time of the raid.

SMITH, SAMUEL D(UVAL)

Resident of Tyrrell County, NC, where he enlisted at age 23 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Present on muster rolls from Sep-Oct 1861 to Mar-Apr 1862 when listed as sick in camp. Then present until Sep-Oct 1862 when on special duty, Nov-Dec 1862 when absent detailed as brigade butcher and on Jan-Feb 1863

muster roll when detailed to ambulance corps. Then present on all muster rolls through Nov-Dec 1863 and on a bounty roll dated April 1, 1864. Captured at a location variously described as being near mine Run, VA or Spotsylvania Court House, VA on May 10, 1864. Imprisoned at Point Lookout, Maryland on May 18, 1864 and transferred to Elmira, New York on August 3, 1864. Appears on a roll of prisoners wanting to take the Oath of Allegiance dated September 30, 1864. Released at Elmira on May 15, 1865 after taking the Oath of Allegiance, at which time he is listed as a resident of Plymouth, NC and described as having a dark complexion, black hair, blue eyes and being 5 foot 10 ½ inches in height. S. D. Smith applied for a soldier's pension from North Carolina on July 1, 1901 in Dare County, NC. At the time of application, he was 63 years of age and a resident of East Lake. He stated that he enlisted in Company A, 32nd NC Infantry Regiment on May 16, 1861. Wounded in right foot by a piece of bomb shell at Gettysburg, PA on July 1, 1863. From exposure and rough usage in the service he is now partially disabled. Approved for class two pension. There is also a letter from the county pension board to the state pension board on July 7, 1913 stating that S. D. Smith, now on a class two pension is not entitled to that and recommending that he be placed in class four.

SMITH, S. T.

The name of S. T. Smith only appears on a roll of members present on August 30, 1906. He is the only Smith listed present that day. The entry was probably meant to be S. D. Smith. The only Smith in the area on census records who matches is Samuel D. Smith.

SMITH, T. H.

There is no T. H. Smith or anything close to it in the service records of Company A, 32nd NC Infantry Regiment. T. H. Smith is the only Smith on the first roster of the association and S. D. Smith is the only Smith on the second roster of the association and both were listed as having served in Company A, 32nd NC Infantry Regiment. There were no new members named Smith in the records of the association between the two rosters. It is therefore likely that T. H. Smith was meant to be S. D. Smith.

SPENCER, BENJAMIN S.

Resident of Tyrrell County, NC, where he enlisted at age 26 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Sick in quarters on muster roll of Nov-Dec 1861. Present on muster rolls from Jan-Feb 1862 to Nov-Dec 1863. Detailed to saw boards on a regimental return of November 1862. Present on a bounty roll of April 1, 1864. Admitted to General Hospital No. 9, Richmond, VA on April 20, 1964 and sent to Jackson Hospital, Richmond, VA on April 21, 1864 for febris intermit. Transferred to General Hospital, Farmville, VA on April 29, 1864 and discharged from there on June 30, 1864. Muster roll of Sep-Oct 1864 lists him as sick in hospital. Admitted to General Hospital No. 9, Richmond, VA on October 9, 1864 and sent to Winder Hospital on October 10, 1864. Present on muster rolls of Nov-Dec 1864 and Jan-Feb 1865. Appears as a rebel deserter on a register of prisoners received and disposed of by the Provost Marshal General, Army of the Potomac on March 30, 1865. Sent to Washington, DC on April 1, 1865 and appears on a register of refugees and deserters of the Provost Marshal General, Washington, DC as received from the Army of the Potomac on April 4,

1865, took the Oath of Allegiance and furnished transportation to Plymouth, NC. Benjamin S. Spencer applied for a soldier's pension from North Carolina on June 29, 1901 in Tyrrell County, NC. At the time of application, he was 65 years of age and a resident of Columbia. He stated that he enlisted in Company A, 32nd NC Infantry Regiment on May 16, 1861. Received wounds at Winchester and Petersburg, VA on July 20, 1863. One was in the right hand, rendering a portion of it useless, and the other was a shell wound and explosion causing deafness. He also has lung disease and mitral valve disease. Approved for class three pension.

SPRUILL, A(BSOLOM) W.

Born in Washington County, NC and enlisted at age 21 at Edenton, NC in Battery B (Edenton Bell Battery), 3rd Battalion NC Light Artillery on January 27, 1862. Mustered in at Camp Mangum, NC on March 27, 1862. Described as a farmer 5 feet, 9 inches in height. Present on all muster rolls through Nov-Dec 1864. Listed as having deserted on April 23, 1865 on a muster roll of officers and men paroled in accordance with a Military Convention entered into on the 26th day of April, 1865, between General Joseph E. Johnston, Commanding Confederate Army, and Major General W. T. Sherman, Commanding United States Army in North Carolina. Roll is dated April 28, 1865 at Greensboro, NC. A. W. Spruill applied for a soldier's pension from North Carolina on July 7, 1902 in Washington County, NC. At the time of application, he was 63 years of age and a resident of Scuppernong. He stated that he enlisted in Moore's Battalion on or about July 1861. No wounds but now unable to work due to infirmities of old age and consumption. Approved for a class four pension. His widow, Nancy J. Spruill, applied for a widow's pension from North Carolina on May 9, 1908 in Washington County, NC. At the time of application, she was 60 years of age and a resident of Roper. Approved for a class four pension.

SPRUILL, DEMPSEY

Enlisted at age 21 in Company H, 17th NC Infantry Regiment (First Organization) at Plymouth, NC on May 3, 1861 and mustered in at Beacon Island on June 20, 1861. Dempsey and the entire company were captured at Hatteras on August 29, 1861. He appears on a record of prisoners of war at Fort Warren, MA where he arrived on November 1, 1861 and was released for exchange on December 17, 1861. Sent to Fort Monroe, VA. Mustered out at Williamston, NC on March 20, 1862. Many members of this unit then reenlisted in Company H, 17th NC Infantry Regiment (Second Organization) but there is no record of Dempsey Spruill in that unit.

SPRUILL, NOAH

Born about 1838 and living in Scuppernong Township, Tyrrell County in 1900. Died in 1907. Seaman on SS Chicora, Confederate States Navy on tombstone. His widow, Mary A. Spruill, applied for a widow's pension from North Carolina on July 5, 1909 in Tyrrell County, NC. At the time of application, she was 72 years of age and a resident of Columbia. Her late husband, Noah Spruill, enlisted in the C. S. Navy gunboat Chicora, stationed at Charleston, SC on or about September 1, 1864. She was approved for a class four pension.

STILLMAN, J(OHN) C.

Appears on a muster roll of Lee's Company, Alabama Light Artillery for Jul-Aug 1864 as having enlisted in July 1864 and being absent with a section of artillery at Little Bethel, NC. The only

other record is a receipt roll for clothing in the 3rd quarter of 1864. The original name of this unit was the Montgomery True Blues, a company in the 3d Alabama Infantry Regiment. This regiment was sent to Virginia in 1861 but saw no action for a year. During this time it was reorganized and the Montgomery True Blues became an independent battery operating in eastern North Carolina, first at Kinston, NC, then at Plymouth, NC and finally at Fort Branch near Hamilton, NC. John C. Stillman applied for a soldier's pension from North Carolina on July 8, 1913 in Washington County, NC. At the time of application, he was 70 years of age and a resident of Creswell. He stated that he enlisted in the Montgomery Blues on or about July 1862 and was paroled at Greensboro. Not wounded but suffering from general debility and senility which has prevented him from working for several years.

STOCKS, JOHN M.

Not listed as a member of the Association, but mentioned as one of the veterans living in Tyrrell and Washington Counties for whom the Association received Crosses of Honor from the Pamlico Chapter of the United Daughters of the Confederacy in 1912. Enlisted in Company E, 61st NC Infantry Regiment on May 14, 1862 in Lenoir County for three years or the war. Mustered into service at Camp Mangum, NC on May 26, 1862 and described as a farmer born in Lenoir County. Absent without leave on the muster in and descriptive roll. Listed as absent with leave since December 14 on the Nov-Dec 1862 muster roll. Present on the Jan-Feb 1863 muster roll and present but sick on the Mar-Apr 1863 muster roll. Present on all remaining muster rolls through 1863 and 1864. (No muster rolls for Jan-Feb 1864, Jun-Jul 1864 & Aug-Sep 1864.) Appears on receipt rolls for clothing on 25 May 1964 and 29 Jul 1864. John Stocks applied for a soldier's pension from North Carolina on July 5, 1909 in Washington County, NC. At the time of application, he was 75 years of age and a resident of Plymouth. He stated that he enlisted in Company E, 61st NC Infantry Regiment on April 1, 1862 and was wounded at Battery Wagner on Morris Island, SC on or about June 20, 1863 when struck in the head by shrapnel. He was wounded again at Fort Harrison, Chapin's Farm, VA when struck in the knee by a musket ball. He was previously drawing a pension which was discontinued due to the value of his property. Approved for class four pension.

TARKENTON, HENRY Z.

Resident of Tyrrell County, NC, where he enlisted at age 20 on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in October 1861. Home on furlough on the muster roll of Sep-Oct 1861 and sick in quarters on muster roll of Nov-Dec 1861. Present on all subsequent muster rolls from Jan-Feb 1862 through Nov-Dec 1863. Present on a bounty roll dated April 1, 1864. Captured on May 10, 1864 at what is variously described as near Mine Run, VA or at Spotsylvania Court House, VA. Imprisoned on May 18, 1864 at Point Lookout, MD and transferred to Elmira, NY on August 3, 1864. Appears on muster rolls from Sep-Oct 1864 through Jan-Feb 1865 as absent, prisoner of war. Paroled at Elmira, NY for exchange and sent to James River on March 2, 1865. Captured again at Plymouth, NC on March 18, 1865 and imprisoned at Point Lookout, MD on March 30, 1865. Released at Point Lookout after taking the Oath of Allegiance on June 20, 1865, at which time he is listed as a resident of Tyrrell County, NC and described as having a fair complexion, dark brown hair, gray eyes and being 5

foot 6 inches in height. H. Z. Tarkenton's widow, Susan Tarkenton, applied for a widow's pension from North Carolina on July 2, 1923 in Washington County, NC. At the time of application, she was 67 years of age and a resident of Creswell. Her husband had enlisted in Company A, 32nd NC Infantry Regiment on May 16, 1861. She was approved for a class four pension.

TARKENTON, JOHN W.

John Tarkenton enlisted in Battery B (Edenton Bell Battery), 3rd Battalion NC Light Artillery on March 1, 1864. Present on all subsequent muster rolls through Nov-Dec 1864. On register of General Hospital, No. 3, Greensboro, NC as admitted for diahrroea on March 7, 1865. Absent sick in hospital in Salisbury on a muster roll of officers and men paroled in accordance with a Military Convention entered into on the 26th day of April, 1865, between General Joseph E. Johnston, Commanding Confederate Army, and Major General W. T. Sherman, Commanding United States Army in North Carolina. Roll is dated April 28, 1865 at Greensboro, NC and parole is effective May 1, 1865. John W. Tarkenton applied for a soldier's pension from North Carolina on July 7, 1913 in Tyrrell County, NC. At the time of application, he was 65 years of age and a resident of Columbia. He stated that he enlisted in 1863 in Battery B, 3rd Battalion, NC Light Artillery. In good physical condition for a man of his age. Has mitral stenosis. Application was disallowed. Applied again on July 3, 1915 in Tyrrell County, NC. At the time of application, he was 67 years of age and a resident of Columbia. He stated that he enlisted on February 4, 1862 in Battery B, 3rd Battalion, NC Light Artillery. Disabled by old age and ill health and heart disease. Application was allowed. Applied to the North Carolina Soldier's Home in Raleigh, NC on January 6, 1917 from Tyrrell County, NC and was admitted on February 12, 1917. Enlisted in Battery B, 3rd Battalion. NC Light Artillery on February 4, 1862 at Bald Head Island on Cape Fear River and was discharged at Greensboro, NC at the end of the war. He is described as 69 years of age, single, of light complexion, 5 feet 3 ¾ inches in height, a carpenter by occupation and his nearest relative is Warren C. Tarkenton of Columbia. There are also service records for a John W. Tarkenton who was born in Tyrrell County and enlisted at age 21 at Columbia, NC in Battery B (Edenton Bell Battery), 3rd Battalion NC Light Artillery on February 4, 1862. Mustered in on March 27, 1862 at Camp Mangum, NC. Described as a farmer 5 feet, 4 inches in height. Present on muster rolls through Sep-Oct 1862. Listed on muster roll as killed at battle of White Hall on December 16, 1863. He also appears on a register of officers and soldiers killed in battle or who died of wounds or disease as having died of wounds on December 16, 1862. Census and other records indicate this was an older man, born about 1842, than the John W. Tarkenton who was born about 1847, survived the war and was later a member of the Confederate Veterans Association.

TARKENTON, JOSEPH W.

Enlisted at age 18 in Company G, 2nd NC Cavalry Regiment on July 18, 1861 in Washington County, NC. Present on muster rolls from Jan-Feb 1862 to Mar-Apr 1863, when listed as absent in hospital. Appears on a regimental return for May 1862 as taken prisoner and now on parole. On the register of the General Hospital, Charlottesville, VA as having been admitted on May 3, 1863 and discharged on June 10, 1863. Listed present on muster rolls from May-Jun 1863 to Sep-Oct 1863 when listed as absent on detail to procure fresh horse. Present on muster rolls from April through September 1864. No further record.

TATEM, ARTHUR H.

Enlisted for one year on June 27, 1861 at the Portsmouth Shipyard in Company F, 41st VA Infantry Regiment. Reenlisted for the war in June 1862, receiving a \$50 bounty. Left sick at Drewry's Bluff when the regiment moved to Richmond on May 28, 1862. Admitted to the General Hospital, Charlottesville, VA on November 12, 1862 and sent to the General Hospital, Farmville, VA with bronchitis where he was admitted on November 14, 1862 and returned to duty on November 22, 1862. Hospitalized for diarrhea at the General Hospital, Danville, VA from June 18, 1863 to July 21, 1863. Promoted to corporal sometime between April 1863 and April 1864. Captured at Burgess' Mill on October 27, 1864 and imprisoned at Point Lookout, Maryland from October 31, 1864 to June 3, 1865 after taking the oath of allegiance. Muster rolls of this regiment do not exist between April 1863 and April 1864 and after October 1864. Arthur H.Tatem applied for a soldier's pension from North Carolina on June 8, 1901 in Tyrrell County. At the time of application, he was 55 years of age. He stated that he had enlisted in Company F, 41st VA Infantry Regiment on July 12, 1861. Wounded at Fredericksburg and Culpeper Court House, VA on May 20, 1863. He suffered from a shell wound and other wounds and was deaf and has bowel disease. On the rolls as a class four pensioner and it is recommended that he be made a class three pensioner. The earlier pension application apparently no longer exists.

TATEM, CAMILLUS E.

Enlisted at age 20 for one year on April 22, 1861 at Washington Point in Norfolk County in Company F, 41st VA Infantry Regiment. Reenlisted for the war in June 1862, receiving a \$50 bounty. Transferred on March 18, 1862 to Company E, 61st VA Infantry Regiment with a group under Lt. Jetson Jett and mustered in on March 24, 1862 at the rank of sergeant. Wounded in the left thigh and buttock on July 30, 1864 at the Crater near Petersburg, Virginia and hospitalized at Chimborazo Hospital No. 4, Richmond, VA on August 2, 1864. Discharged from Chimborazo and granted a forty-five day furlough to Halifax County, VA on October 9, 1864. Hospitalized in November 1864 in General Hospital No. 9, Richmond, VA. Returned to duty. Paroled at Libby Prison in Richmond in April 1865.

TERRY, GEORGE W.

Enlisted August 14, 1862 at Hamilton, NC. Present on muster rolls of Company D, 13th NC Light Artillery Battalion from Nov-Dec 1863 to Sep-Oct 1864. (A survey of muster rolls for other members of this unit indicates they don't exist prior to Nov-Dec 1863.) A muster roll covering the period Nov 1864 through Feb 1865 carries him as absent without leave on February 24, 1865.

THOMAS, JOHN H.

Resident of Tyrrell County, NC, where he enlisted at age 24 and was mustered in as a Corporal on May 16, 1861 in Company L, 12th NC Infantry Regiment. Present or accounted for until the company was redesignated and reassigned as Company A, 32nd NC Infantry Regiment in

October 1861. Elected by Company A to serve as 2nd Lieutenant on January 25, 1862. Promoted to 1st Lieutenant on September 13, 1862. A regimental return at Drury's Bluff for November 1862 states that he had been sick in Petersburg since November 15, 1862. Promoted to Captain of Company A on June 18, 1863. Returned from sick furlough the night of July 1, 1863 and was wounded in the shoulder and disabled on July 3, 1863 at Gettysburg, PA. Admitted to General Hospital No. 10 and released on 30 days furlough to Windsor, NC. Present for duty again on Muster Roll of Nov–Dec 1863. He was retired to the Invalid Corps on May 13, 1864 due to chronic diarrhea but was later reported to be in command of Company A and Company D in Jan–Feb 1865. John H. Thomas applied for a soldier's pension from North Carolina on October 1, 1910 in Tyrrell County, NC. At the time of application, he was 78 years of age and a resident of Berkley, VA. He stated that he had enlisted in Company A, 32nd NC Infantry Regiment on May 16, 1861. Shot under the left shoulder at Gettysburg. Not affected by wound. Age renders him disabled. Application was disallowed, probably because there was no doctor's examination and statement.

THURSTON, WILLIAM B.

Enlisted in Henrico County, VA on December 13, 1864 in what is more generally known as the Jackson Flying Artillery or the Johnson Artillery, which served in several different Virginia artillery battalions. At the time of his enlistment and in service records his unit was known as Capt. Clutter's Company, Virginia Light Artillery. Present on muster rolls of Nov-Dec 1864 and Jan-Feb 1865. Admitted to Chimborazo Hospital No. 4, Richmond, VA on March 15, 1865 and transferred to Chimborazo Hospital No. 1, Richmond, VA on March 17, 1865 with a gunshot wound to the right thigh. He was furloughed on March 27, 1865.

VANHORN, J(OHN) H(AMILTON)

J. H. Vanhorn is listed in the records of the Confederate Veterans Association as having been in Company H, 17th NC Infantry Regiment. However, there are no existing service records that can be found on him in that unit. There is a John H. Vanhorn listed as a member of William H. Spencer's Company of partisan rangers, but there are no service records related to this either. His widow, A(nn) D. Vanhorn applied for a widow's pension from North Carolina on June 24, 1901 in Pasquotank County, NC. She was 72 years of age and a resident of Elizabeth City at the time of application. She said her husband had enlisted in Company H, 17th NC Infantry Regiment and was wounded at Newbern, NC.

WHITE, JAMES W.

Enlisted in Company H, 17th NC Infantry Regiment (Second Organization) at Hamilton, NC on April 2, 1862 and mustered in at Camp Johnson, NC on June 17, 1862. Described as a 28-yearold seaman born in Currituck County, NC who was 5 feet, 11 inches in height. Present until muster roll of Jul-Aug 1863 when absent on leave under General Order 5. Then present until Jan-Feb 1864 when reported to have deserted on January 22, 1864 from a scout in Washington County. The next muster roll is for Sep-Oct 1864, on which he is reported as being a prisoner of war since February 1864. Records show he was captured near Plymouth, NC on January 26, 1864 and imprisoned at Point Lookout, MD on February 27, 1864. He was released from Point Lookout on June 21, 1865 after taking the Oath of Allegiance, at which time he is listed as a resident of Washington County, NC and described as having a dark complexion, dark brown hair, gray eyes and being 5 foot 10 inches in height. Sally White, widow of W. J. White, applied for a widow's pension from North Carolina on July 11, 1910. At the time of application, she was 75 years of age and a resident of Columbia. Her husband, W. J. White, served in the 17th NC Infantry Regiment.

WOODLEY, ELI

Enlisted at age 25 in Company G, 17th NC Infantry Regiment (Second Organization) in Washington County, NC on June 15, 1863. Present on muster rolls from May-Jun 1863 through Jan-Feb 1864. Absent sick on the muster roll for Apr 30-Aug 31 1864 and absent sick in hospital at Wilson, NC on the Sep-Oct 1864 muster roll. No muster rolls or other records subsequent to that.

WYNNE, SPENCER D.

Born in Tyrrell County and enlisted at age 22 in Company G, 17th Infantry Regiment (Second Organization) at Plymouth, NC on April 16, 1862. Mustered in at Camp Mangum on May 29, 1862. Described as a farmer who is 6 feet, 2 inches in height. Present on all muster rolls until Apr 30-Aug 31 1864 when listed as absent sick at hospital in Wilmington, NC. Listed on Sep-Oct 1864 muster roll as having deserted while on picket October 19, 1864 carrying off arms and accoutrements. Appears on a register of oaths taken by Rebel deserters Headquarters Provost Marshal, Bermuda Hundred, VA on October 20, 1964. To be sent to Norfolk, VA from there. No muster rolls or other records subsequent to that.

Appendix B – Unit Histories

Most of the men who belonged to the Tyrrell County Confederate Veteran's Association served in Company A, 32nd NC Infantry Regiment, Companies G & H, 17th NC Infantry Regiment or Battery B, 3rd Battalion, NC Light Artillery. A brief history of each of these units is recounted below. By referring to each soldier's service record you can then determine what battles they participated in and put their service in context.

32nd NC Infantry Regiment

Company A, 32nd NC Infantry Regiment was initially organized as Company L, 12th NC Infantry Regiment (2nd Regiment, NC Volunteers) and was raised in Tyrrell County with Edmund C. Brabble elected as its Captain and commanding officer. In October of 1861 the company was transferred to the 32nd NC Infantry Regiment, but four of the ten companies designated to comprise this regiment were captured at Cape Hatteras on August 29, 1861. Consequently, the six remaining companies were organized as the 1st Battalion NC Infantry on November 29, 1861 with this company being designated Company A initially and later as Company F. Edmund C. Brabble was appointed second in command of the battalion with the rank of Major. The battalion was initially stationed near Portsmouth, VA and in February of 1862 it was sent to perform coastal defense duties in eastern North Carolina. In May it returned to Virginia and was stationed at Suffolk, Petersburg and Drewry's Bluff on the James River. While at Drewry's Bluff the 32nd NC Infantry Regiment was finally formed, incorporating the 1st Battalion NC Infantry, and with this company designated Company A and Edmund C. Brabble as Colonel commanding the regiment. The company functioned thereafter as Company A, 32nd NC Infantry Regiment for the remainder of the war and its history is incorporated into that of the regiment.

Of particular note is the fact that all of the initial field and staff officers of the 32nd NC Infantry Regiment were originally from Company A. A further coincidence is that they were all members of the same Episcopal Church. Colonel Brabble was a strict disciplinarian but was humane and took good care of his soldiers. Overall, the regiment had excellent leaders. The brigade to which the regiment was attached was that of General Junius Daniel.

The 32nd NC Infantry Regiment remained at Drewry's Bluff until early January and did not participate in the Maryland campaign of Lee's Army of Northern Virginia, thereby missing the battles of Second Manassas and Antietam. In early January of 1863, Daniel's Brigade was moved to the eastern part of North Carolina and did not participate in any major battles but was involved in Confederate operations against New Bern and Washington, both of which were unsuccessful, but not through fault of the regiment.

On May 17, 1863 Daniel's Brigade moved to Virginia where it joined the Army of Northern Virginia and remained a part of it until the surrender at Appomattox. Having missed

the major battles of Fredericksburg and Chancellorsville, the brigade prepared for the Gettysburg campaign, in which it was among the first units to cross the Potomac River and among the last to recross. The brigade marched as far as Carlisle, Pennsylvania, the farthest point of penetration by the Army of Northern Virginia, until they were ordered to join the bulk of the army near Gettysburg. Arriving shortly after midday on July 1, 1862, the battle had already begun and the brigade was committed at a railroad cut north of town. It lost 78 men that day. On July 2 the brigade supported the artillery stationed behind the Theological Seminary. Here is sustained many casualties while under fire from the Union artillery. The brigade was moved to the northeast of the town of Gettysburg on July 3 and advanced against Culp's Hill, suffering many casualties, and withdrew to the west after dark. Over the 3 days of the battle, the 32nd NC Infantry Regiment lost 147 men killed or wounded.

After withdrawing over the Potomac River into Virginia, the regiment was not involved in any major actions and went into winter camp near the Rapidan River. On May 4, 1864 they left camp and began a campaign that saw almost continuous marching and fighting until the surrender at Appomattox. On May 5 they were heavily engaged in the battle of the Wilderness. On May 10 at Spotsylvania Court House the brigade to their right was penetrated, subjecting them to deadly flanking fire and they lost many officers and men, including Colonel Brabble, before the penetration was reduced. Two days later on May 12 a salient in the Confederate line was penetrated in a battle that became known as the Bloody Angle and some of the most desperate fighting of the Civil War ensued. The trains of Lee's army were in danger and Daniel's Brigade, among others, was committed to blunt the attack. Lee himself attempted to join the counterattack but was sent to the rear by his soldiers and General Daniels was killed. Eventually a new line of defense was established. All told, between May 4 and May 19, the regiment lost over one half of its men in killed, wounded and captured.

On June 13, after the battle of Cold Harbor, the brigade, now under General Grimes, was sent to Lynchburg and began what became known as the Valley Campaign under General Jubal Early. Advancing up the Shenandoah Valley, the regiment reached Harper's Ferry on July 4, where it assisted in loading captured supplies and provisions. Leaving there toward Frederick, MD, they encountered Union forces under General Lew Wallace at the Monocacy River and a battle ensued in which the brigade was held in reserve. Leaving there and after a fatiguing 30-mile march under a hot sun, the brigade arrived at the fortifications around Washington, DC near what was later Walter Reed Army Hospital and in sight of the dome of the Capitol. The brigade was the front infantry unit of Early's army, closer to the fortifications than any other. After some skirmishing it was determined that the fortifications were too strongly defended to attack. As luck would have it, two Corps of the Army of the Potomac had just arrived and Early's army was outnumbered four to one. The decision was therefore made to return to Virginia. It is of interest to note that President Lincoln visited the fortifications during the skirmishing and thus became the only President of the United States to be under enemy fire while in office.

The regiment safely returned to Virginia and then began a series of skirmishes and fights in which they advanced and retreated up and down the Shenandoah Valley. This culminated in

the battle of Cedar Creek on October 19, in which a victory was initially won but ended in disaster. This was the last battle of any importance fought by the regiment in the Valley Campaign.

In mid-December of 1864 they went into winter camp at Swift Creek near Petersburg where they finally enjoyed a brief rest. In February, 1865 they moved to Southerland's Station on the extreme right of Lee's extended line of defense around Petersburg. After four weeks they were stationed in the trenches in front of Petersburg near the site of the battle of the Crater the previous year. On March 25 the regiment participated in a last desperate attack by Lee to break through the Union lines which nearly succeeded. April 2 saw the Union attack that broke through the Petersburg defenses and the withdrawal that ended in the surrender at Appomattox began. At the end there was a mere handful of men left in the regiment who were paroled at Appomattox. From Company A there was D. G. Cowand, then a Colonel commanding Grimes' Brigade, William H. Hardison, then Sergeant Major of the regiment and privates W. E. Alexander, W. F. Biggs & F. Meekins.

17th NC Infantry Regiment

Originally organized as the 7th Regiment, NC Volunteers, all but two companies were captured at Fort Clark and Fort Hatteras, which constituted the defenses of Hatteras Inlet, on August 27, 1861. The remaining two companies were captured shortly thereafter at Fort Bartow on Roanoke Island. After being exchanged, the regiment was reorganized at Camp Mangum as the 17th NC Infantry Regiment with William F. Martin as Colonel and Thomas J. Norman and Stewart L. Johnson as Captains of Companies G & H, respectively.

The regiment was initially assigned to duties in Eastern North Carolina and performed picket duty, keeping an eye on Union forces in New Bern, Washington and Plymouth. In December of 1862 detachments of the regiment assisted in capturing Washington and Plymouth. In 1863 the regiment was made part of a brigade commanded by Brigadier General James G. Martin and stationed at Fort Branch, Kinston and Wilmington. On February 2, 1864 the regiment was part of a successful attack on Newport, which drove Union forces back to Fort Macon. However, because of General Pickett's inability to capture New Bern, the regiment withdrew the next day.

The Union campaign in 1864 in Virginia began with General Grant crossing the Rapidan River on May 4 with his army of 140,000 and General Butler coming up the James River to the Bermuda Hundreds Peninsula with an army of 30,000 and strong naval support, threatening both Richmond and Petersburg. To meet this threat the 17th NC Infantry Regiment, along with other forces operating in North Carolina were sent to Richmond and Petersburg and placed under General Beauregard's command. On May 17 the regiment participated in an attack on Drewry's Bluff that forced Butler back into his fortified base at Bermuda Hundreds. On May 20 the 17th led an assault on these lines and drove Butler back under protection of their naval

gunboats on the James and Chickahominy Rivers, thus "bottling them up." In this action the regiment lost about 175 men killed and wounded.

By this time the battles of the Wilderness and Spotsylvania Court House had been fought. In his turning movement Grant ordered his cavalry and infantry forces to seize the heights at New Cold Harbor. On June 1, the regiment, now part of Hoke's Division, attacked these forces and drove them back to Old Cold Harbor, securing the heights around New Cold Harbor and Gaines' Mill. The murderous battle of Cold Harbor followed on June 3, it being the only attack General Grant ever regretted making. The Union lost over 8,000 men in just one hour and soldiers were pinning notes to their uniform so they could be identified. General Grant then moved his Army to the south bank of the Appomattox River in a move to capture Petersburg. Hoke's Division, with the 17th NC Infantry Regiment, was moved to Drewry's Bluff on June 14 to be in position to act as Lee's reserve or assist Beauregard at Petersburg. The door to Petersburg now lay open and Hoke's Division was committed to stop the Union advance, fighting a series of battles from June 16 through June 19, retreating to the lines they would hold during the siege of Petersburg on June 20. On that date, Martin's Brigade totaled 2200 men. By September there were only 700 half-starved men remaining. In October the brigade was sent to the Richmond front where it participated in several minor engagements.

Now under General Kirkland, the brigade, along with the rest of Hoke's Division was sent to Wilmington, NC in late December to counter the anticipated Federal land and naval attack upon Fort Fisher. This attack was easily repulsed by Hoke's Division and the division was withdrawn back to Wilmington. On January 14 a new Union attack was launched and before Hoke's Division could respond, a line of defense was established across the peninsula from the ocean to the Cape Fear River, thus cutting off Fort Fisher. The afternoon of the next day, the skirmishers of Kirkland's Brigade were ordered to drive in the Union pickets so a reconnaissance of the Union position could be made. This was partially successful, but General Bragg, the overall commander, decided not to attack. That evening Fort Fisher surrendered and the last port of the Confederacy was closed.

Sherman's advancing forces from the south caused Wilmington to be evacuated on February 22. Hoke's division retreated up the line of the Wilmington & Weldon Railroad until arriving at Goldsboro. At the same time three Federal commands were converging on Goldsboro, Sherman's of 70,000, Scofield's of 30,000 from Wilmington and Palmer's of 15,000 from New Bern. On 8 and 10 March the division attacked Palmers force at Wise's Fork, suffering the only repulse the 17th NC Infantry Regiment ever received during the war and losing over half its men. It then became necessary to concentrate all available Confederate forces against Sherman's army advancing from Averasboro, and Hoke's division was sent to Bentonville. One last battle was fought there against Sherman's army on 19 March. Confederate forces were then withdrawn through Raleigh and Chapel Hill to Centre Church where they were surrendered.

Battery B, 3rd North Carolina Light Artillery (Edenton Bell Battery)

The 3rd North Carolina Light Artillery Battalion was organized near Raleigh, North Carolina in late 1861 and was mustered into Confederate service on February 27, 1862. It initially consisted of three batteries recruited from Northampton, Chowan, Tyrrell and Hertford Counties. The recruits from Tyrrell County were mostly in Battery B. The Battalion first was assigned to the Department of North Carolina and Southern Virginia, serving in the Richmond, Virginia area. It was sent to Virginia to assist in the defense of Richmond during what is known as the Peninsula Campaign before receiving its horses and artillery and occupied Battery 7 in the Richmond defenses near Mechanicsville. After the withdrawal of Federal forces, the battalion remained near Richmond until September 1962 when it was ordered to the Valley of Virginia to join Lee's Army. Arriving just after the battle of Sharpsburg, the battalion was initially near Martinsburg, Virginia. While near Culpeper Court House, Virginia in December 1862 the battalion was ordered to Fredericksburg, Virginia where they were assigned to forces protecting a railroad bridge south of Fredericksburg, a vulnerable point on Lee's main supply line. After the battle at Fredericksburg the battalion returned to North Carolina.

The battalion was ordered to Wilmington and had to wait for its horses and equipment to arrive by a long, overland march. When the equipment and horses had arrived at Goldsboro there were only enough serviceable horses to equip one battery. Battery B was equipped and ordered to Kinston to help counter 20,000 Federal troops advancing from New Bern. The right section of Battery B under Lieutenant Nelson McCleese was ordered to White Hall to defend the bridge there over the Neuse River. While there they were bombarded by over a dozen pieces of artillery and subjected to heavy infantry fire throughout the day and into the night. Having lost but two men and horses, one of his guns that had been struck repeatedly was finally disabled by a shell that also struck down five cannoneers. At that point Lieutenant McCleese was relieved by a fresh section from Battery B under Lieutenant J. G. Moore. The firing soon ceased and the Federal forces attempted a crossing further up stream where Lieutenant John M. Jones with the center section of Battery B did effective service.

After the battle of Goldsboro Battery B reunited with the rest of the battalion at Wilmington, where it remained in camp until about November 1, 1863. At that time each battery took up positions in defense of the Cape Fear region, Battery A being positioned north of Fort Fisher as part of a force protecting the Wilmington & Weldon Railroad and Kenansville, Battery B on Smiths Island (Bald Head) and Battery C at Fort Caswell. In the winter of 1864 General Pickett was sent with a force from Lee's Army to attack Federal forces holding New Bern. Battery A participated in this campaign and distinguished itself with a most unusual artillery charge, routing a Federal artillery position. Pickett's mission ultimately failed and there were no more movements of elements of the battalion until around November 1, 1864.

The port of Wilmington now being the only port through which the Confederate Government could receive foreign shipments, Federal naval and ground forces were marshalled to capture Wilmington. In preparation, Battery A was posted at Smithville and Batteries B and C remained at Bald Head and Fort Caswell, respectively. A Federal fleet appeared in December and attacked Fort Fisher on December 24, but after two days of battle they were repulsed. Subsequently Battery A was sent to Sugar Loaf, Battery B remained at Bald Head and Battery C was sent to Fort Fisher. The Federal fleet returned on January 12, 1865 and bombarded Fort Fisher and on January 15 the combined naval and land forces were successful in capturing Fort Fisher. The greater part of Battery C was captured at Fort Fisher, sustaining heavy losses. The remainder of Battery C, along with the rest of the battalion, reported to Fort Anderson on February 10, 1865 and were then deployed to cover the retreat of Confederate forces from Wilmington.

The battalion was then engaged in that last major battle of the Civil War at Bentonville, North Carolina on March 19 - 21, 1865. From there they retreated toward Raleigh and was formally surrendered on April 26, 1865.
